

# Instructions For Obtaining A Hearing Date

## (Revised September 2008)

Hearings on motions will ordinarily be set on Tuesday or Thursday of each week. Emergency hearings may be set with the permission of the court on any day. There will be particular weeks where hearing dates are not available because court is not in session or those dates are reserved for a trial.

You do not need to contact the court to select a hearing date. First, find the appropriate day and time from the chart below that matches your type of motion. Second, select an available date that allows you to meet notice and service requirements, put the date and time on the front page of your motion, and file the motion with the court.
