Chapter 13	All pending chapter 13 cases, regardless of the filing date, together with pending related adversary proceedings, are reassigned to Judge Maureen A. Tighe.
Adversary Proceedings	In addition to the adversary proceedings that are reassigned as indicated above, pending adversary proceedings set forth on Exhibit A (attached) are reassigned to Judge Maureen A. Tighe without the main bankruptcy case.

For pleadings filed on or after June 1, 2005, the initials "AG" following the bankruptcy case/adversary proceeding numbers shall be replaced with the new initials "KL," "GM," or "MT," as applicable.
