**PUBLIC NOTICE**

**RE: NEW webPACER SYSTEM FOR THE LOS ANGELES DIVISION**

**EFFECTIVE: MARCH 23, 1998**

The PACER system for the **Los Angeles Division only** will be upgraded to a new browser-based format as of March 23, 1998. The new system, known as webPACER, will have the "look and feel" of an Internet website, and will provide a more efficient and user-friendly method by which the public can access Court information. The set-up software for the new webPACER system is currently available for downloading from the current PACER system and the Court's website, which is located at <http://www.cacb.uscourts.gov>. The new system will support Internet Explorer versions 3.0 and 4.0 and Netscape Navigator versions 3.0 and 4.0.

The new webPACER system for the Los Angeles Division will be available to the public on March 23, 1998, and will be available concurrently with the current PACER system until July 24, 1998. During the transition period from March 23 to April 23, 1998, the new webPACER system will be available to the public free of charge. **From March 23 to April 23, 1998, the telephone numbers to access the new webPACER system and the current PACER system in the Los Angeles Division will be as follows:**

Beginning on April 24, 1998, usage of the webPACER system will be charged at the current PACER usage rate of 60 cents per minute, as mandated by the United States Judicial Conference. New webPACER accounts will automatically be established for current PACER users with active PACER accounts. If you have not yet registered with the PACER Service Center and would like to establish a new account, please call (800) 676-6856 between the hours of 8:00 a.m. and 5:00 p.m., CST.

**From April 24 to July 24, 1998, the telephone numbers to access the new webPACER system and the current PACER system in the Los Angeles Division will be as follows:**

**After July 24, 1998**, the current PACER system will no longer be available, and only the new webPACER system will be available, in the Los Angeles Division. The telephone numbers to access webPACER will remain **(213) 620-0031 (Local)** and **(800) 257-3887 (Toll Free)**.

The PACER systems for all other divisional offices will remain unchanged, until further notice.
