

24 NOTICE IS GIVEN that on November 29, 2005, at 10:00 a.m., or  
25 as soon thereafter as the matter may be heard, in Courtroom "302"  
26 of the United States Bankruptcy Court, 3420 Twelfth St.,  
27 Riverside, California, Arturo Cisneros, Chapter 7 Trustee of the  
28 estate of Empresas Castell, Inc., dba Cha-Cha Foods, dba Del Rio's

1 Fresh Mexican Grill and Cantina, fdba Del Rio's Taqueria Grill  
2 ("Debtor"), will move the Court pursuant to 11 U.S.C. §363(f) and  
3 Local Bankruptcy Rule 9013-1(a)(7) for an order: (1) authorizing  
4 the Trustee to sell for the sum of \$12,500 to Mariposa Palm  
5 Canyon, Inc. ("Buyer"), or such other person who may appear at the  
6 hearing and submit a higher acceptable bid, all of the Trustee's  
7 rights, title, and interests in miscellaneous equipment,  
8 furniture, inventory and other personal property, all of which are  
9 described on the first two pages of the three-page list that is  
10 attached as Exhibit "1" and which are located at 155 South Palm  
11 Canyon Drive, # B1, Palm Springs, California (collectively, the  
12 "Personal Property"), on an as-is basis, without any warranties,  
13 recourse or representations, free and clear of all liens in  
14 accordance with the terms of the Motion;

15       2.     authorizing the Trustee to execute any and all documents  
16 that may be necessary to consummate the sale of the Personal  
17 Property;

18       3.     finding that the Buyer, or any other person who appears  
19 at the hearing and submits a higher acceptable bid and becomes the  
20 purchaser, is a good faith purchaser under 11 U.S.C. § 363(m); and

21       4.     abandoning other personal property consisting of:  
22 (a) the Debtor's four liquor licenses; (b) miscellaneous,  
23 equipment, furniture, inventory and other personal property that

7 expenses of administration and certain priority claims, there are  
8 no liens affecting the Personal Property.

9 2. The purchase price of \$12,500 is fair and reasonable and  
10 the sale is in the best interests of the creditors and the estate.

11 3. The Buyer, or any other person who appears at the  
12 hearing and submits a higher acceptable bid and becomes the  
13 purchaser, is a good faith purchaser under 11 U.S.C. § 363(m)  
14 because the purchaser is an identifiable purchaser who is giving  
15 value relative to the sale of the Property.

16 4. The Other Personal Property is burdensome to the estate  
17 and is of inconsequential value and benefit to the estate.


