**RE: TRANSFER/REASSIGNMENT OF JUDGE TIGHE CASES**

For bankruptcy cases and adversary proceedings reassigned to Judge Theodor C. Albert, initials following those bankruptcy case or adversary proceeding numbers shall be changed from "MT" to "TA."

For all bankruptcy cases and adversary proceedings transferred to the San Fernando Valley Division, new bankruptcy case and adversary proceeding numbers will be assigned that are preceded by the location code "SV" and followed by the initials "MT." All pleadings filed in these cases on or after June 1, 2005 shall be filed in the San Fernando Valley Division with these new numbers, location code, and Judge Tighe's initials.
