9 **ORDER DIRECTING THE JOINT ADMINISTRATION OF THE DEBTORS'**

11 **THIS MATTER CAME BEFORE THE COURT** on the Ex Parte Motion (the
12 "Motion") of Consolidated Freightways Corporation, Consolidated Freightways Corporation of
13 Delaware, Redwood Systems, Inc., Leland James Service Corporation, CF Airfreight
14 Corporation and CF MovesU.com Incorporated, debtors and debtors-in-possession herein
15 (collectively, the "Debtors"), for entry of an order granting joint administration of their


