ORDER: (1) APPROVING BIDDING PROCEDURES MOTION [DOC. NO. 314], AS AMENDED BY AMENDED BIDDING PROCEDURES MOTION [DOC. NO. 330], AND AS FURTHER AMENDED BY

THE COURT IN RED; AND (2) APPROVING EMPLOYMENT OF THE MENTOR GROUP AS FINANCIAL ADVISORS

The Court having read and considered the Motion for an Order Establishing Bidding Procedures for the Sale of Substantially all of the Estates' Assets ("Bidding Procedures Motion") [Docket No. 314], the Amended Bidding Procedures and Terms of Sale ("Amended Bidding

Procedures") [Docket No. 330] and the Declaration Of Fritz Strehlow In Support Of Amended Bidding Procedures And Terms Of Sale ("Fritz Dec.") [Docket No. 331] submitted by Transat Trade, Inc. ("Transat") and Chateau Vegas Wines, Inc., ("Chateau"), debtors and debtors in possession (collectively, "Debtors"), and for the reasons set forth in the Memorandum of Decision Overruling Objection of Southern Wine and Spirits to Entry of Order Approving Bidding Procedures Motion, and good cause appearing,

# IT IS ORDERED AS FOLLOWS:

- 1. The Bidding Procedure Motion, as amended by the Amended Bidding Procedures, and as further amended by the Court in red, is approved;
- 2. <u>The Sale Procedures:</u> Under the Sale Procedures, only Qualified Bidders may participate in the sale process. To be a "Qualified Bidder", a person or entity that is interested in purchasing the Debtors' Assets must submit to Transat's counsel, Ian S. Landsberg, Esq., Landsberg & Associates, A Professional Law Corporation, 5950 Canoga Avenue, Suite 605, Woodland Hills, CA 91367, Telephone (818) 855-5900, Facsimile (818) 855-5910; ilandsberg@landsberg-law.com, a "Bid", as set forth below, so that it is received 14 calendar days prior to the hearing (the "Bid Deadline") on the Motion for an Order Approving the Sale of Substantially all of the Estates' Assets Free and Clear of Liens ("Sale Motion") [Docket No. 313].
  - a. The amount of the Bid shall be not less than \$250,000.00 for both Debtors' business assets. Qualified Bidders are those prospective bidders who deliver to Transat's counsel (i) a good funds deposit in the amount of 10% of the minimum bid amount; (ii) written evidence from a third party reasonably satisfactory to the Debtors and/or The Mentor Group of its financial ability to perform the obligations under the Purchase Agreement, as that term is defined immediately below; (iii) a form of a proposed purchase and sale agreement ("Purchase Agreement") for the Bid; and (iv) a written statement signed by the Qualified Bidder agreeing that such Bid, if successful at the hearing on the Sale Motion, shall be bound by the terms of the Purchase Agreement. No Bids that are contingent as to financing shall be considered.
  - b. Prospective Bidders' Right to Inspect. As used in this paragraph, "Prospective Bidder" means any person or entity that submits to Transat's counsel, Ian S. Landsberg, Esq., a refundable deposit of \$10,000. All other capitalized terms have the meaning set forth in the Asset Purchase Agreement, attached as Exhibit A to the Amended Bidding Procedures Motion [Doc. No. 330]. Debtors shall, upon commercially reasonable terms, permit Prospective Bidders to inspect the Purchased Assets, including (1) the leased premises located at 14415 South Main Street, Gardena California 90248 (the "Transat Premises"); (2) the leased premises located at 3625 W. Teco Avenue, Suite 6, Las Vegas, Nevada 89118 (the "Chateau Premises"); (3) the machinery, equipment, fixtures, furniture, point-of-sale software, and motor vehicles located at the Transat Premises or Chateau Premises; (4) inventories of wine, champagne, and any other beverage or food product located at the Transat Premises or Chateau Premises; and (5) all books and records relating to the Purchased Assets, in the forms maintained in the ordinary course of business. Debtors may require Prospective Bidders to sign a non-

disclosure agreement, and Prospective Bidders may not use any information acquired through an inspection for any purpose other than to determine whether to submit a bid for the Purchased Assets. If executed, any such non-disclosure agreement shall be filed with the Court.

- c. By no later than September 24, 2014, the Mentor Group shall submit to the Court the Sales Book used to market the businesses (referenced on page 4 of the Sale Procedures Motion, Doc. No. 314). The Sales Book shall inform prospective bidders of their right to inspect the business assets as set forth in ¶ b.
- d. By no later than November 5, 2014, the Mentor Group shall submit a declaration describing the efforts that were undertaken to market the assets.
- 3. The Sale Hearing / Auction and Overbid Requirements: The hearing to approve the Sale Motion is set for November 19, 2014, at 10:00 a.m. ("Sale Hearing"). If multiple Bids are received from Qualified Bidders, the Debtors will provide the Court with a status report as to bids received not later than seven (7) calendar days before the scheduled hearing and conduct an auction (the "Auction") for a sale of the Assets at the Sale Hearing.
  - a. The Auction will take place at the Bankruptcy Court at the Sale Hearing.
  - b. Only a Qualified Bidder who has submitted a Qualified Bid, as that term is defined below, will be eligible to participate at the Auction. At such Auction, Qualified Bidders will be permitted to increase their bids. In the event there are more than one Qualified Bidder, the Debtors will conduct an Auction (i) with each successive overbid to be in not less than \$10,000 increments, with 70% of the allocation to Transat and 30% of the allocation to Chateau, and (ii) setting any such additional procedural rules that it determines to be reasonable under the circumstances for conducting the Auction.
  - c. Upon conclusion of an Auction, the Debtors shall (i) review each Bid on the basis of financial and contractual terms and the factors relevant to the sale process, including those factors affecting the speed and certainty of consummating the Sale and (ii) identify the highest and otherwise best offer (the "Successful Bid"). The Debtors shall then request at the Sale Hearing that the Court approve the Sale to the individual/entity with the Successful Bid (the "Successful Bidder"). The Debtors may adopt rules for the bidding process that are not inconsistent with any of the provisions of the Bankruptcy Code, any Bankruptcy Court Order, or these Sale Procedures; and
  - d. Following a hearing approving the sale of the Assets to a Successful Bidder, if such Successful Bidder fails to consummate an approved sale because of a breach or failure to perform on the part of such Successful Bidder, (a) it will forfeit its good funds deposit to the Debtors and the Debtors may pursue any and all of its options at law and in equity with respect to such breach and (b) the next highest or otherwise best

alternative Bid ("<u>Alternative Bid</u>"), as disclosed at the Sale Hearing, shall be deemed to be the Successful Bid and the Debtors shall be authorized to effectuate such sale without further order of the Bankruptcy Court, subject to consent of such Bidder at the Sale Hearing, or (c) the Debtors may reschedule the Auction to a later date and time convenient to the Court.

- e. The Alternative Bid, or any other Bid that is designated by the Bankruptcy Court as a "backup" bid at the hearing on the Sale Motion, shall remain binding upon the offeror as an Alternative Bid, and in the event the Successful Bidder fails to close as required, such Alternative Bid shall be deemed accepted by the Debtors and approved by the Bankruptcy Court. In the event the Debtors intend to proceed with a closing with respect to any bid designated by the Bankruptcy Court as a "backup" bid at the hearing on the sale motion, the Debtors shall provide to the party whose bid was designated as a "backup" bid not less than ten (10) days' prior written notice of the date set for the closing with respect to such "backup" bid.
- 4. Debtors shall serve on all creditors, a Notice of the Auction and Hearing on the Debtors' proposed sale no later than 3 calendar days after entry of this Order;
- 5. Objections, if any, to the sale shall be filed and served on Debtors counsel no later than fourteen (14) days before the Sale Hearing. Replies, if any, thereto shall be filed and served on the objecting party no later than seven (7) days before the Sale Hearing; and
  - 6. The Application to Employ The Mentor Group as Investment Banker is approved.
