OVERBID PROCEDURES

1. Any party wishing to overbid shall deposit a Cashier's Check in the amount of \$100,000 with Debtors' counsel, Peter Susi, payable to Robert Lee Rains and Betty Sue Rains, Debtors-in-Possession, at least 48 hours prior to the scheduled hearing on the Motion.
2. The sale shall be for all cash and on the same terms as the proposed sale to the Buyer as reflected in Exhibit "B" to the Motion.
3. First minimum overbid shall be \$2,300,000 or as otherwise may be fixed by the court at the hearing, with subsequent overbid intervals as fixed by the court. Successful overbidders shall open escrow within 3 business days following the hearing. The overbidder's \$100,000 deposit shall be forfeited if the overbidder fails to open escrow, or close the purchase in a timely manner, through no fault of the Debtors.


