**ATTACHMENT 1**

In order for any party to participate in an overbid procedure regarding the acquisition of the Property, Trustee requests that the parties comply with the following provisions:

a. Each party, including Mohammad Rasian (“Buyer”) interested in participating as an overbidder must be present either physically or telephonically at the hearing on the Motion or represented by an individual or individuals with the authority to participate in the overbid process;

b.
