OVERBID PROCEDURE

Trustee proposes the following overbid procedure be used at the hearing on the sale motion (the "Hearing") for the purpose of considering bids:

A. Each potential bidder (other than the buyer proposed in the sale motion) in order to qualify as a bidder at the Hearing, shall attend the Hearing and, prior to the commencement of the Hearing,

(1) present to Trustee a cashier's check in the amount of Two Thousand Dollars (\$2,000.00) (the "Earnest Money Deposit") made payable to Encore Escrow ("Encore"). Trustee shall refund the Earnest Money Deposit if Trustee accepts the bid of another bidder;

(2) present to Trustee a completed and executed written offer to purchase signed by the bidder that contains terms and conditions that are, in Trustee's business judgment, similar or superior to the terms and conditions of the offer by Buyer generally described above and specifically contained in the Agreement;

(3) present to Trustee proof that the bidder has the financial ability to pay, within seven (7) days after entry of the Sale Order approving sale of the Real Property to the highest Bidder at the Hearing (the "Highest Bidder"), the balance of any bid made by such bidder, such proof to be deemed acceptable or unacceptable by Trustee in her sole discretion, subject to approval by the Court; and

B. The initial overbid shall be a total of \$11,000.00, i.e., \$1,000.00 more than the sales price of \$10,000.00, and all additional overbids must be made in minimum increments of \$500.00.

If Highest Bidder fails to close the sale escrow within twenty (20) days of entry of the sale order, Highest Bidder shall forfeit the Earnest Money Deposit and the next highest bidder shall pay the next highest bid to purchase the real property.
