

**ORDER DENYING MOTION FOR  
DEFAULT JUDGMENT**

In accordance with the contents of this court's Memorandum of Decision filed concurrently, IT IS ORDERED that:


1. Plaintiffs, Ray Kangarloo's and Homa Kangarloo's motion for default judgment is denied without prejudice to the Plaintiffs moving before the district court for relief pursuant to 11 U.S.C. §110(i)(1).

2. Defendant, Michael Arotionian, shall disgorge and turn over to Amy Goldman, the duly appointed Chapter 7 Trustee, located at 221

1 North Figueroa Street, Suite 1400, Los Angeles, California, the sum  
2 of \$675.00 pursuant to 11 U.S.C. §110(h)(2).

3 3. Defendant, Michael Arotionian, shall pay to the United States  
4 Treasury the sum of \$1,500.00, constituting fines imposed under 11  
5 U.S.C. §110(d)(2); (f)(2) and (g)(2) for violations of 11 U.S.C. §§  
6 (d)(1), (f)(1) and (g)(1). The sum of \$1,500.00 shall be in the form  
7 of a certified check, payable to the United States Treasury and  
8 delivered to the Intake Section, Clerk of the United States Bankruptcy  
9 Court, San Fernando Valley Division, 21041 Burbank Boulevard, Woodland  
10 Hills, California 91367.
