Plaintiffs Ocean Mission Park, LLC and Craig Campbell (“Plaintiffs”),
having moved for summary judgment of non-dischargeability of debt, and the
motion having come before the Honorable Robert Kwan, United States
Bankruptcy Judge, and the Court having issued its order granting Plaintiffs’
motion for summary judgment against defendant Mehrdad Taheripour

1 (“Defendant”) on Plaintiffs’ second cause of action for non-dischargeability of
2 debt pursuant to 11 U.S.C. § 523(a)(2)(B);

4 IT IS ORDERED, ADJUDGED AND DECREED that for the reasons set
5 forth in the Court’s order dated on or about October 4, 2014, that certain State
6 Court Amended Judgment issued against Defendant and in favor of Plaintiffs by
7 the Los Angeles Superior Court, in the State of California in Case Nos. SC
8 104571 and BC 457833, in the face amount of \$16,300,780.89, is a non-
9 dischargeable debt pursuant to 11 U.S.C. § 523(a)(2)(B), which is hereby
10 excepted from any general discharge that may be obtained by Defendant in
11 bankruptcy, and said debt shall remain valid and in full force.

12 IT IS FURTHER ORDERED, ADJUDGED, and DECREED that the other
13 claims set forth in Plaintiffs’ Second Amended Complaint in this Adversary
14 Proceeding for non-dischargeability of debt pursuant to 11 U.S.C. § 523(a)(2)(A)
15 and (a)(6), the first and third causes of action, are hereby dismissed with
16 prejudice.
