# New Clerk of Court Appointed

After a thorough search and vetting process by judges. Kathy Campbell will begin her service as the Clerk of Court for the United States Bankruptcy Court - Central District of California on February 1. Chief Deputy of Operations Michael Rotberg has been serving as Acting Clerk of Court since September.

Ms. Campbell worked at the Court for

many years and served as Chief Deputy of Administration until 2006 when she left to work for the City of Santa Paula, Ms. Campbell was chosen from a very talented pool of applicants, and Chief Judge Vincent Zurzolo said, "We feel confident that Ms. Campbell will do an excellent job of leading our Clerk's staff as it faces new and continued challenges."

# Judges Encourage Pro Bono Participation

The Bankruptcy Judges of the Central District of California would like to extend an open invitation, strongly urging bankruptcy attorneys to volunteer for pro bono opportunities.

Over the past year, bankruptcy filings in the Central District have risen to over 100,000. the highest in the nation. Pro Se filers make up 25% of all filings. The overwhelming volume has put a strain on organizations that assist low-income people in bankruptcy.

Volunteer opportunities can range from a few hours at a clinic to full representation in a Chapter 7 case or adversary proceeding. While most pro bono opportunities are for debtor assistance. low-income creditor assistance is also needed.

Contact information for local groups seeking volunteers and the opportunities available are posted on the Court's website under the "Don't Have an Attorney?" section. These programs are structured so that creditor or business attornevs may volunteer without conflicts or concerns about becoming a debt relief agency.

# Changes to Time Computation Rules Effective December 1, 2009

The U.S. Supreme Court approved amendments to the time period calculations in the Federal Rules of Bankruptcy Procedure, which became effective December 1, 2009.

The time-computation amendments to the Federal Rules of Bankruptcy Procedure include changes to 12 rules that have resulted in a reduction by one day (from 15 to 14 days) of the time to take action. Schedules, statements and other documents that were required to be filed within a 15-day deadline prior to December 1 are now subject to a 14-day deadline.

The Court has revised the Local Bankruptcy Rules Forms and Court Forms that are affected by the new national computation standards. These forms became effective December 1, and the revised Local Bankruptcy Rules become effective January 4, 2010.

# Court Participates in Next Generation CM/ECF Architecture Study

The Administrative Office of the U.S. Courts and representatives from MITRE Corporation, a notfor-profit federally funded research and development center, visited the United States Bankruptcy Court on December 1. The team met with management, operations and IT staff to analyze the Court's software architecture and develop a next generation system that would more effectively meet the Court's needs

Court staff heavily emphasized to the team the performance issues that burden large courts. Issues identified to the AO include the need to improve report-running, scalability, accountability, and better ways to work with local programs and the Court's large Pro Se demographic.

The MITRE Architecture Study Team in turn proposed several ideas to incorporate into the next generation software, including establishing a data-mart offsite, an archive system for CM/ECF, and utilizing two databases for distinct user and research functions without interfering with overall efficiency.

MITRE Corporation will present two design proposals to the AO in January 2010. The Court will remain heavily involved in the next generation team stakeholder meetings in order to review progress and ensure the Court's needs are met.

# New and Revised Forms Effective December 1

In December, the Judicial Conference of the United States approved a new Official Bankruptcy Form B27 (Reaffirmation Agreement Cover Sheet), and amended Official Bankruptcy Form B1D (Exhibit D). The new Reaffirmation Agreement Cover Sheet will be used when calendaring and issuing notices for reaffirmation hearings. The revised Exhibit D reflects the updated time computation standards requiring credit counseling certificates and debt repayment plans to be submitted within 14 days (and not 15 days) of petition filing. The Court has required the use of the new and amended forms as of December 1, 2009.

# Court Manual Revised to Include New Zip Code Classifications

The Court Manual was revised with changes effective January 4, 2010. Revisions include an updated Appendix B that now includes changes to existing zip codes and communities served by the San Fernando Valley Division. Public Notice 09-019 was issued October 8, detailing the affected zip codes.

Request for Courtesv Notification: The Court has created a "Courtesy party in CM/ECF. Attornevs are reminded that when filing a Request for Courtesy Notification. search for "Courtesy NEF" and do not add any address information to the party. Additionally, please check the "attorney association box" to associate yourself to the case. Following these steps ensures that you are properly notified of case activity.

Opening an Adversary Complaint: When filing an adversary complaint, always add yourself (the attorney filing the document) as the attorney for the plaintiff. This will ensure that proper legal representation for the plaintiff is recorded and ensure all parties notified of case activity. Never add an attorney for the defendant - the Court enter information for defendant's the legal representation answer to the complaint is filed.
