## LABF PAYS TRIBUTE TO JUDGE NEITER AT NIGHT WITH THE JUDGES

On July 6, the Los Angeles Bankruptcy Forum (LABF) honored Judge Richard M. Neiter during the "Annual Night with the Judges" program. Over 130 members of the local bankruptcy community, including Chief Judge Sheri Bluebond, Judges Barry Russell, Thomas B. Donovan, Victoria S. Kaufman, Deborah J. Saltzman, Mark S. Wallace, Sandra R. Klein, Neil W. Bason, and Julia W. Brand, and Clerk of Court Kathleen J. Campbell, gathered at the L.A. Hotel Downtown for the panel discussion and tribute to Judge Neiter, who will retire later this year after more than fifty years working as a bankruptcy lawyer and judge.

Chief Judge Sheri Bluebond moderated the discussion, during which Judges Russell, Kaufman, Saltzman, Wallace, Klein, Bason, and Brand each commented on a case from Judge Richard M. Neiter and LABF President the previous year.

After the Miranda Decision: How Federal Courts Defined the Rights of the Accused."

To compete in the Ninth Circuit Contest, students were required to enter local contests in their districts. In the Central District of California, the District and Bankruptcy Courts jointly sponsored the Central District's local contest. The first, second, and third place winners of the local contest were automatically entered to compete in the Ninth Circuit Contest.

Then, Judge Neiter's law clerk, Lovee Sarenas, talked about the positive impact he has made in the bankruptcy community, both as a practitioner and a judge. The audience gave Judge Neiter a standing ovation, and LABF President Joel Weinberg presented him with a token of appreciation.

Judge Neiter spoke briefly about how much he loved being a lawyer and how valuable it is for young lawyers to have judges as mentors. He urged those who are able to mentor to do so, and expressed his gratitude to his family, friends, and colleagues.

Wilner participated in the ceremony. Also attending were Bankruptcy Clerk of Court Kathleen J. Campbell, members of the Clerk's Office staff, and many proud family members and friends of the finalists.

Following introductory remarks from Chief Judge Bluebond, Judge Klein, and Judge Kronstadt, Judge Klein recognized the students whose essays received an honorable mention: Simran Chopra, Andy Escobar, Marc Flores, Camille Lin, Tayanna Torres Montelongo, Osvaldo Ramirez, Marquise Sanders, and Jennifer Biempica Villalba. Judge Klein then presented awards to the winners of the Central District Contest: Emily Ramirez, who was awarded third place and received \$500, Serena Davis, who was awarded second place and received \$750, and Daniela (Dani) Mirell who was awarded first place and received \$1,000.

In her insightful essay, which also won the Ninth Circuit Contest's first-place prize, Dani discussed how the courts safeguard "Miranda rights" and why those rights are so important to our system of justice. As the winner of the Ninth Circuit Contest, Dani will receive an additional \$2,000, two round-trip airplane tickets and two nights' accommodations to attend the Ninth Circuit Judicial Contest in Big Sky, Montana next month where she will be presented with her award. # SMARTSCAN ELECTRONIC DOCUMENT DELIVERY SERVICE NOW AVAILABLE TO THE PUBLIC

Since June 1, the electronic document delivery service SmartScan has been available to the public. Through SmartScan, users can receive PDF copies of documents stored in the Federal Records Centers (FRC) by email.

Requesting electronic copies of documents through SmartScan is faster, cheaper, and easier than retrieving paper documents from the FRC. For a fee of \$19.90 plus 65 cents per page, users can request a PDF of any archived court document up to a maximum of 100 pages. Requests may be submitted to the Court at the intake windows or by mail.

Effective June 10, a new LBR form has been approved, while four existing forms have been revised and one has been retired. The new form is F 8002-1.APPEAL.FEE.WAIVER.APP, "Application for Waiver of the Appellate Fee in a Chapter 7 Case."

Minor technical changes have been made to the revised forms: F 1007-1.MOTION.DEC.EXTEND, "Debtor's Motion to Extend Time to File Case Opening Documents"; F 2090-1.2.APP.NONRES. ATTY, "Application of Non-Resident Attorney to Appear in a Specific Case"; F 2090-1.2.ORDER. NONRES.ATTY, "Order on Application of Non-Resident Attorney to Appear in a Specific Case"; and F 8004-1.1.NOTICE.TRANSCRIPT, "Notice of Transcript(s) Designated for an Appeal."

Form F 1017-1.1.NOTICE.DEBTOR.CONVERT, "Notice of Debtor's Motion to Convert Case Under 11 U.S.C. § 706(a)," has been retired.

Abstract of Judgment

The Court requires the following:

- Submit one original and two copies of the Abstract with an entered copy of the Judgment or Order attached.
- The signature on the Abstract must be original.
- The Abstract forms must be completely filled out and will not be issued with blank lines, alterations, or white out.
- 4. Filing fee is required.

#### Writ of Execution

The Court requires the following:

- Submit one original and one copy of the Affidavit and Request for Issuance of Writ of Execution.
- 2. The Affidavit must have an original signature on the second page.
- One original and two copies of the Writ of Execution with an entered copy of the Judgment or Order attached.
- 4. The Affidavit and Request for Issuance of Writ of Execution and Writ of Execution forms must be completely filled out and will not be issued with blank lines, alterations or white out.

#### Writ of Possession

The Court requires the following:

- Submit one original and two copies of the Writ of Possession with an entered copy of the Judgment or Order attached.
- Use Judicial Council of California Form EJ-130 or submit the form in pleading format.
