Passing of the Gavel

On January 25, 2011, the Passing of the Gavel from Chief Bankruptcy Judge Vincent P. Zurzolo to Judge Peter H. Carroll was commemorated at the Ninth Circuit Court of Appeals in Pasadena.

Judge Peter Carroll gave the opening remarks, followed by Senior Circuit Judge Michael Daly Hawkins, Judge Erithe A. Smith, and retired Judge David N. Naugle. Each speaker applauded Judge Zurzolo for his accomplishments and congratulated the new Chief Judge. Their comments were followed by Judge Sheri Bluebond and Clerk of Court Kathleen J. Campbell, both of whom presented gifts of appreciation on behalf of the judges and Clerk's Office.

Chief District Judge Audrey B. Collins and Judge Virginia A. Phillips carried out the presentation and order of appointment, during which Judge Peter Carroll was formally appointed as Chief Judge. Chief Judge Peter H. Carroll thanked the presenters and everyone responsible for hosting the event. He stated "The Court faces significant challenges in the next four years," with the continued increase in caseload and reduction in budget. Despite these challenges, Chief Judge Peter H. Carroll stated he was definitely looking forward to his time as Chief Judge.

Upon the conclusion of Chief Judge Peter H. Carroll's remarks, a reception was held in the courthouse lobby. The Honorable Mark S. Wallace

Prior to his appointment to the bench, Judge Wallace was counsel at the law firm of Stutman, Treister & Glatt, P.C. He has worked on medium to large-size corporate and partnership Chapter 11 reorganizations. From 1979 to 1991, Judge Wallace was a shareholder at the Phoenix law firm of Osborn, Maledon, P.A., where he practiced tax and corporate law, and was the firm's principal tax lawyer.

Judge Wallace is a member of the Board of Directors of the Los Angeles Bankruptcy Forum and has served as its liaison to the Pro Bono Bankruptcy Subcommittee since 2006. He also served as a director on the Board of Directors of Public Counsel from 2006 to 2009, and as chair from 2005 to 2007 of the Bankruptcy and Workouts Committee, an organization in which he was a founding member.

A native of East Brunswick, New Jersey, Judge Wallace received his A.B. degree from Princeton University, where he graduated summa cum laude and Phi Beta Kappa. He received his J.D. in 1977 from Columbia University, School of Law, where he was the *Notes and Comments Editor* of the Columbia Law Review and a Harlan Fiske Stone Scholar.

The Honorable Scott C. Clarkson

Prior to his appointment to the bench, Judge Clarkson was the managing attorney of Clarkson, Gore & Marsella, APLC, in Torrance, California. He has been a practicing attorney for over 28 years. As a former Legislative Assistant to a U.S. Congressman from 1977 through 1982, assigned to the House of Representatives' Judiciary Committee, he was a direct observer and participant in the creation of the 1978 Bankruptcy Code in the U.S. House of Representatives. Since 1989, he has practiced in California at all levels of bankruptcy law, including working with individuals and public and private corporations in chapters 7 and 11. Judge Clarkson has also practiced as a litigator, who was significantly involved in both the prosecution and defense of preference and fraudulent avoidance actions, and many types of recovery actions.

Judge Clarkson is a longtime member of the Los Angeles County Bar Association. He served on its Bankruptcy Committee, as chair from 2004 to 2006, and its Commercial Law and Bankruptcy Section, as chair from 2008 to 2009. Judge Clarkson was also a member of the Bar Advisory Board Committee of the U.S. Bankruptcy Court for the Central District of California.

A native of Houston, Texas, Judge Clarkson received his B.A. from Indiana University in 1979 and his J.D. from George Mason University School of Law in 1982.

The Honorable Wayne E. Johnson

Prior to his appointment to the bench, Judge Johnson was, the founder of the Law Office of Wayne Johnson in Redlands specializing in business and consumer bankruptcy cases. He has worked as a bankruptcy attorney in the Commerce and Finance Group of Brobeck, Phleger & Harrison, LLP, in Los Angeles from 1996 to 2003, and at Lewis, D'Amato, Brisbois & Bisgaard, LLP, in Los Angeles from 1994 to 1996. He also served as a law clerk for the Honorable David N. Naugle, retired bankruptcy judge for the Central District of California.

Judge Johnson was an adjunct professor of law at Trinity Law School in Santa Ana from 1999 to 2001, where he taught "Bankruptcy and Creditors Rights" and "Ethics and the Profession." He

has published numerous articles on bankruptcy matters and actively served in the LA County Bar Association. He served as the president and a board member of the Inland Empire Bankruptcy Forum; as the education co-chair of the California Bankruptcy Forum; and is a member of the American Bankruptcy Institute.

Anative of Pasadena, California, Judge Johnson received his B.A. in 1989 from Cornell University, where he graduated magna cum laude. He received his J.D. from the University of Pennsylvania Law School in 1992.

CM/ECF Tips

Running Judge/Trustee/341(a)
Meeting Assignment

Attorneys who file petitions electronically are required to upload the creditors and run the Judge/Trustee/341(a) Meeting Assignment. Doing so not only ensures notices are sent out timely, but also decreases processing time.

If you do not, the Court will automatically the Judge/ run Trustee/341(a) Meeting Assignment to all cases where creditors have been uploaded. However, this will make it unlikely for two or more chapter 7 cases filed concurrently to obtain the same trustee and 341(a) meeting assignments. If you try to run the Judge/Trustee/341(a) assignment after the Court, you may be presented with an error message. Please review your cases for a Judge/Trustee/341(a) Meeting Assignment contacting the ECF Help Desk.
