# Ninth Circuit Appoints Two New Bankruptcy Judges

Chief Judge Alex Kozinski of the Ninth Circuit Court of Appeals announced the appointment of Assistant U.S. Attorney Catherine E. Bauer and Los Angeles attorney Deborah J. Saltzman to serve as bankruptcy judges in the Riverside division of the Central District of California.

Ms. Bauer and Ms. Saltzman will assume judgeships left vacant after the retirements of Judge Mitchel R. Goldberg and Judge David N. Naugle in 2008.

Ms. Bauer joined the Office of the U.S. Attorney in 2001. As an assistant U.S. attorney, she represents the federal government in all civil, non-tax bankruptcy matters in consumer and commercial cases in the Central District.

She graduated from UCLA in 1982 with a degree in political science and was admitted to the State Bar of California in 1985 after graduating from the USC Gould School of Law. Ms. Bauer has served on the Central District's bankruptcy mediation panel since

1995 and is an active member of several bar associations, the Federal Executive Board, and the Girl Scouts of Greater Los Angeles, among other organizations.

A New York City native, Ms. Saltzman has practiced bankruptcy in the Los Angeles area for the last 10 years. Currently an associate with the law firm DLA Piper, Ms. Saltzman received her B.A. in history from Amherst College in 1991 and her J.D. from the University of Virginia School of Law in 1996.

Ms. Saltzman is active in the local community. She has taught a continuing education program on bankruptcy and restructuring, and is a mentor to young people involved in the local chapter of the Young Storytellers Foundation. She was voted by fellow attorneys as a Southern California Rising Star for five consecutive years (2004-2008).

## CM/ECF Hardware and Software Upgrade Scheduled

The Court will be performing an upgrade of its CM/ECF hardware and software beginning at 4:00 P.M. Friday, October 30, 2009, through Monday, November 2, 2009. During this time, access to CM/ECF (Live and Training), LOU, PACER, and VCIS will not be available. Access is expected to be restored by 5:00 P.M., Monday, November 2, 2009.

During the upgrade, the Court will be reconfiguring the CM/ECF system into a split-server configuration to improve system performance. The Court also will be upgrading CM/ECF from version 3.3.1 to version 3.3.2. Please refer to Public Notice 09-021 for additional information.

While most changes in this newest release of CM/ECF will be transparent to users, the most prominent change includes reinforcement of the privacy protection requirements under F.R.B.P. 9037. In this release, CM/ECF has been further modified to refine the language electronic filers see when logging into the system; require acknowledgment that the filer has read and will comply with the redaction requirements; provide links to the Federal Rules regarding redaction; and display another reminder each time the filer actually files a document.

During this upgrade, the Court will be open during normal business hours to accept filings at the Intake windows until 4:00 P.M. The Court may, however, issue manual receipts with no case number, judge assignment or trustee assignment on Monday, November 2, 2009.

# Zip Code Changes to Affect Northeastern Los Angeles County

Effective Monday, January 4, 2010, zip codes for the northeastern area of Los Angeles County, as listed in the table below, will be moved from the San Fernando Valley Division to the Los Angeles Division. The area affected includes Lancaster, Palmdale, Castaic, and surrounding cities. All new bankruptcy cases filed on or after January 4 in the zip codes listed must be filed in the Los Angeles Division, while all bankruptcy cases filed in the San Fernando Valley Division prior to January 4 will remain at the San Fernando Valley Division.

## Court Manual Revised to Include New Forms, Judge's Copy Rules

The Court Manual was revised on October 8, with changes effective immediately. Revisions include a new appendix listing exceptions to serving a Judge's Copy of filed documents; simpler instructions for serving a Judge's Copy of proposed order via LOU; and six new or revised Local Bankruptcy Rules forms.

## Wireless Network Available in Courtroom Floors

A wireless network is now available for use by attorneys and trustees, free of charge, on all court-room floors in all divisions throughout the Central District of California. A wired equivalent privacy (WEP) key is required to access the network. This WEP key, along with instructions on accessing the system, was emailed to all registered ECF users.

## New Form Available in CM/ECF

As of September 10, the CM/ECF system supports the electronic filing of a new bankruptcy form entitled "Notice of Attorney Change of Address or Law Firm" on multiple cases. The event code is located under Bankruptcy/ BK – Multi-Case Docketing/ Notice of Change of Address (multi). ECF users may submit a single PDF form with a list of all affected cases in which this document is being filed. Only a maximum of 10 cases should be entered in the system at a time when using this multicase docketing feature. Once submitted, Court staff will update the user's information in CM/ECF.

Tips on Using the New Notice of Change of **Attorney Address or Law** Firm: The Notice of Change of Attorney Address or Law Firm is not the same as the Substitution of Attorney form. Using the form in lieu of a Substitution of Attorney form does not comply with Local Rules and will require the form to be resubmitted. Additionally, the Notice of Change of Attorney Address or Law Firm may be used to change an attorney's email address for one specific case. To change an attorney's email address in all of their cases, please refer to Section 3 of the Court Manual for the correct procedures. Finally, when batch-filing the new form on numerous cases, the notice PDF must have the list of cases in which the document is being filed and the box entitled "See attached list..." must be checked.
