Court Continues Efforts to Improve CM/ECF Performance

Outages and slowdowns to CM/ECF adversely affect all members of the Court community – judges, Clerk's office staff, attorneys, debtors, and creditors, among others. The Court is actively working with the Administrative Office of the U.S. Courts to develop some concrete solutions to recent performance concerns.

System outages and slowdowns have typically stemmed from two different issues: hardware failures at the Court and the scalability of CM/ECF's current architecture. Hardware failures—such as unexpected drive errors have at times caused long outages due to the need to acquire and replace systems equipment. Large reports, and the Court's incredibly large volume of filings relative to the rest of the country, have stressed the database that forms the foundation for CM/ ECF and led to periods of extreme system slowness.

The Court has taken a variety of approaches to remedy these challenges. To address the hardware issue, the Court has acquired a new, more robust server, and is in the process of reconfiguring CM/ECF into a split-server configuration. The database that supports CM/ECF will be supported on a separate server from the actual CM/ECF application, and the split server architecture should improve systems performance. The Court anticipates having these new servers in place in the coming months.

The Court is also working with the Administrative Office of the U.S. Courts to implement changes to CM/ECF that would improve how data is retrieved during queries.

Internally, the Court has changed some processes, such as reducing or outright eliminating running large queries.

Accessibility to the CM/ECF system is a top concern for the Court, and the Court apologizes for any inconvenience. For more information on CM/ECF, please visit the Court's web site, www.cacb.uscourts.gov.

CM/ECF Systems Upgrade Coming Soon

The Court is in the process of upgrading the servers that support CM/ ECF. Installation of the new servers will require for CM/ECF and related systems to be temporarily unavailable. Judge Bufford to Begin Handling Riverside Chapter 13 Cases

Active Chapter 13 cases in Riverside will not be affected, and Judge Bufford will continue to receive cases filed in the Los Angeles Division.

RECAP Software Usage Security Concerns and Restricted Use

The U.S. Bankruptcy Court - Central District of California would like to make CM/ECF users aware of certain security concerns relating to a software application or "plug-in" called RECAP, which was designed by a group from Princeton University to enable the sharing of court documents on the Internet.

Once a user installs RECAP, documents that are subsequently accessed via PACER are automatically sent to a public Internet repository. Other RECAP users are then able to see whether documents are available from the Internet repository. RECAP captures District and Bankruptcy Court documents, but has not yet incorporated Appellate Court functionality. At this time, RECAP does not appear to provide users with access to any restricted or sealed documents.

Please be aware that RECAP is "open-source" software, which can be freely obtained by anyone with Internet access and modified for benign or malicious purposes, such as facilitating unauthorized access to restricted or sealed documents. Accordingly, CM/ECF filers are reminded to be diligent about their computer security practices to ensure that documents are not inadvertently shared or compromised.

Additionally, the Court would also like to remind fee-exempt PACER users that any transfer of data obtained as of the result of a fee exemption is *prohibited* unless expressly authorized by the Court. Therefore, fee-exempt PACER users must refrain from the use of RECAP.

The prohibition on transfer of information received without fee is not intended to bar a quote or reference to information received as a result of a fee exemption in a scholarly or other similar work.

The Court and the Administrative Office of the U.S. Courts will continue to analyze the implications of RECAP or related-software, and we will advise you of any ongoing or further concerns.

San Fernando Valley Help Desk Profiled

The San Fernando Valley's Self-Help Desk was profiled in the August 3rd edition of the *Los Angeles Daily News*. In the story, various visitors to the help desk said the volunteer staff made the bankruptcy process significantly less daunting and intimidating. The article notes that the desk, which operates on Mondays and Thursdays in the Woodland Hills courthouse, has served more than 850 clients through June 2009.

The desk, which opened in September 2007, is the product of an ongoing collaboration between San Fernando Valley Division Judge Maureen A. Tighe and the Neighborhood Legal Services of Los Angeles County, who provides the clinic with volunteers and a legal assistant. Spanish Translation of Frequently Asked Questions Now Available

The Court released a Spanish translation of the Frequently Asked Questions (FAQs) in late July. The nearly 100 FAQs provide helpful information on a variety of topics for debtors, creditors, and attorneys.

The translation of the FAQs was funded by a grant from the Central District Attorney Admissions Fund and is the culmination of months of work by San Fernando Division Judge Maureen A. Tighe and a team of local attorneys. The initial translation of the FAQs was completed by Ernesto A. Schweikert and reviewed by Magdalena Reyes Bordeaux of Public Counsel and Riverside bankruptcy attorney Lazaro E. Fernandez, under the leadership of attorney Jason Wallach of Gladstone Michel Weisberg Willner and Sloane ALC. Additional support was provided by Joey Alarcon of Bet Tzedek, and Marisa Hawkins and Aimee Meraz of Public Counsel. Self-Help Desk and Chapter 7 Clinic Opens in Los Angeles Division

A self-help desk and Chapter 7 clinic opened August 17 in the Los Angeles Division. The desk is open Monday and Wednesdays from 10:00 a.m. to 1:00 p.m. on the 9th floor, adjacent to the Court's Intake area. The desk provides debtors without legal representation with general information on Chapter 7 and Chapter 13 bankruptcy procedures, forms, and referrals for additional legal assistance. Income eligible individuals interested in getting more information on filing Chapter 7 bankruptcy can apply at the Self-Help Desk for participation in the Chapter 7 Clinic.

The Los Angeles Self-Help Desk and Chapter 7 clinic are sponsored by Public Counsel, the Central District Consumer Bankruptcy Attorneys Association, and the Los Angeles County Bar Association Commercial Law and Bankruptcy Debtor Assistant Project Subcommittee.



CM/ECF Tips

Selecting the Correct Hearing Information: Avoid calendaring errors by verifying the hearing date against the Self-Calendaring information on the Court's website, or if necessary, contacting the courtroom deputy for the applicable judge. Calendaring errors could require that hearings be rescheduled, among other delays. For selfcalendaring procedures and other judge-specific information, consult the Court's website at www. cacb.uscourts.gov under Information > Judges' Procedures/Information.

Selecting the Correct **Docket Event Code:** Using the correct docket event code greatly expedites the review and processing of important court documents. Entering a keyword, such as "motion," in the Search feature of CM/ECF will bring up a list of all possible relevant docket codes with that specific keyword. Feel free to contact the ECF Help Desk for assistance if the proper docket event code is not located through the CM/ECF Search tool.
