Judge Samuel L. Bufford Retires with Nearly 25 years of Service

On August 31, 2010, Judge Samuel L. Bufford retired with almost 25 years of service at the United States Bankruptcy Court in the Central District of California. Upon his retirement from the bankruptcy court, Judge Bufford is joining the faculty at Pennsylvania State University, School of Law and School of International Relations

Judge Bufford was appointed to the bench on November 25, 1985. and was reappointed on March 23, 2000. He presided over more than 100,000 cases and over 3,000 Chapter 11 cases. Some of his highest profile cases included Vicki Lynn Marshall (a.k.a. Anna Nicole Smith) and First Capital Holdings Corporation cases.

During his time on the bench, Judge Bufford worked with attorneys to develop Local Rules for Chapter 13 cases. He also served on the Rules Committee that rewrote the Court's Local Rules after the adoption of the present bankruptcy code. In addition, he taught law and philosophy at Ohio State University, University of Southern California, Harvard University, and Queensland University of Technology in Australia.

Judge Bufford received his J.D. from the University of Michigan School of Law in 1973, magna cum laude. Prior to his appointment to the bench. Judge Bufford practiced law in the areas of securities and anti-trust litigation. He practiced law at Paul, Weiss, Rifkind, Wharton and Garrison in New York from 1974 to 1975; at Sullivan, Jones and Archer in San Francisco from 1977 to 1979; at Musick, Peeler and Garrett in Los Angeles from 1979 to 1981; at Rifkind and Sterling in Beverly Hills from 1981 to 1982; and at Gendel, Raskoff, Shapiro and Quittner in Los Angeles from 1982 to 1985. Additionally, Judge Bufford taught at Ohio University as an assistant professor of law and adjunct professor of city and regional planning from 1975 to 1977. Since 1988, he has served as an adjunct professor of law at the University of Southern California.

We thank Judge Bufford for his contributions to the Court in the past 24 years and wish him all the best in retirement and in his future endeavors.

Judge Peter H. Carroll Relocates to Los Angeles Division

As of August 23, 2010, Judge Peter H. Carroll has relocated from the Riverside Division to the Los Angeles Division. With a few exceptions, all of the judge's pending Riverside bankruptcy and adversary proceedings were reassigned to Judges Meredith A. Jury, Catherine E. Bauer, and Deborah J. Saltzman on August 13, 2010. The initials "MJ," "CB," and "DS" (for Judges Jury, Bauer, and Saltzman, respectively) will now follow the case or adversary proceeding number of the reassigned matters.

The Riverside Division bankruptcy cases and adversary proceedings retained by Judge Peter Carroll will remain Riverside Division cases, but will now be heard in Courtroom 1539 in the Los Angeles Division. Judge's copies must be served to the judge at his Chambers in the Los Angeles Division, room 1534.

Reassignment of Judge Bufford's Bankruptcy and Adversary Proceedings

As of August 23, 2010, Judge Samuel L. Bufford's pending bankruptcy and adversary proceedings were reassigned to Chief Judge Vincent P. Zurzolo and Judge Peter H. Carroll. All chapter 13 cases were reassigned to Chief Judge Zurzolo, while the majority of chapter 7, chapter 11, chapter 15, and § 304 cases were reassigned to Judge P. Carroll, except for a few cases that will be transferred to Judge P. Carroll on September 1, 2010. The initials of the successor judge for the bankruptcy and adversary proceedings are "VZ" for Chief Judge Zurzolo and "PC" for Judge Carroll.

Hearings for cases assigned to Chief Judge Vincent P. Zurzolo will be heard in Los Angeles Division Courtroom 1368 and hearings for cases assigned to Judge P. Carroll will be heard in Los Angeles Division Courtroom 1539.

The Judicial Conference Advisory Committees on Bankruptcy and Criminal Rules are seeking comments on proposed amendments to the Federal Rules of Bankruptcy Procedure (FRBP) and the official bankruptcy forms.

The proposed FRBP amendments affect FRBP 3001 Proof of Claim, FRBP 7054 Judgments; Costs, and FRBP 7056 Summary Judgment.

Proposed revisions will be made to the following official bankruptcy forms:

- Plan of Reorganization in Small Business Case under Chapter 11 (Official Form B25A)

Judges Provide Case Administration Tips to Santa Ana Bankruptcy Bar

On July 16, 2010, the Orange County Bankruptcy Forum hosted a discussion on expediting case management. Judges Erithe A. Smith, Theodor C. Albert, and Robert Kwan offered those in attendance tips that would help expedite the processing of their matters.

Some of the tips discussed included the timely service of judge's copies for filed documents, requesting *ex parte* and shortened time proceedings for only truly urgent matters, and completing reaffirmation agreements thoroughly to provide sufficient evidence for the judge to determine the presence or absence of undue hardship.
