#### Section 362 Lunch and Learn Session Held



Chief Judge Vincent P. Zurzolo



On June 16, 2008, Hon. Vincent P. Zurzolo hosted a "Brown Bag Lunch and Learn" session on the topic of "How to Get Section 362 Orders Entered and Served Correctly and Quickly." More than 80 members of the bar and public attended. The presentation focused on orders regarding Section 362 motions while also addressing generally applicable issues of notice, service, and acceptance of electronic signatures on stipulations and proofs of service. A handout of guidelines was distributed which included a revised "Proof of Service" and "Service List for Entered Order."

Judge Zurzolo reviewed current practices that require re-evaluation due to the ability to electronically deliver documents. He discussed how these decades-long habits cost unnecessary labor and expense for court and law firm staff. Judge Zurzolo discussed that Federal Rules of Bankruptcy Procedure ("FRBP") limit the court's duty to deliver entered orders and limit requests for special notice. He also discussed how the FRBP, Local Bankruptcy Rules ("LBR") and controlling General Orders allow for additional persons or entities to be served with an entered order without placing the burden on the court to process extra copies and stuff envelopes.

Jeff Cozad, one of Judge Zurzolo's law clerks, reviewed details of the handouts. This included an explanation of the three service categories and a demonstration of how to search a bankruptcy case or adversary proceeding docket to determine who receives electronic service of orders from the court. A procedure was discussed for Section 362 motions resolved by stipulation, so that signatures on the Adequate Protection pages can first be filed, followed by electronic lodging of the order via Lodged Order Upload ("LOU").

Special emphasis was made of the following:

- 1) The U.S. Trustee receives electronic service from the court of all orders;
- Case trustees receive electronic service from the court of all orders in bankruptcy cases, and the court is considering extending this to orders in adversary proceedings;

#### ENHANCEMENTS TO L.O.U.

Use of the Court's electronic Lodged Order Upload (L.O.U.) program continues to increase. Since it's inception in November 2007, more than 10,500 orders have been electronically lodged. In May, nearly two-thirds of eligible orders were electronically lodged through L.O.U. Each of the district's 21 Judges has received several orders through L.O.U. from more than 700 different attorneys.


In ongoing efforts to enhance L.O.U. and to encourage increase usage on June 1, 2008, the Court enhanced L.O.U. to allow for the submission of additional order types. The selection list previously available during the relating process was restricted to a limited number of motions/application types. Users of L.O.U. can now upload orders and relate them to the following additional events:

## BANKRUPTCY FILINGS IN THE CENTRAL DISTRICT CONTINUE TO LEAD THE NATION

The Central District of California led the nation for the second consecutive quarter with 12,106 total bankruptcy cases filed during the first quarter of calendar year 2008. The number of filings increased by 73% over the 6,995 cases filed during the first quarter of 2007.

Since the first quarter of 2006, the first full quarter following the enactment of the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005 (BAPCPA), cases filed district-wide have grown 312%, while averaging a 19.9% quarterly increase.



Overall, the Central District led the nation with 39,137 filings for the 12-month period ending March 31, 2008. This represented a 79% increase over the 21,869 cases filed over the same period in 2007, and outpaced the national average by 43%. The Central District is projecting in excess of 60,000 filings in 2008, equivalent to the number of filings in 2004, the last year prior to BAPCPA.

#### **CM/ECF TIPS!**

**Incomplete Petitions:** When opening an Incomplete Petition you **cannot** use the Case Upload feature that may be available through your software. You must use the conventional method to open an incomplete case and change the default for Deficiencies to "Y" (for Yes) in order to be prompted to identify the missing documents. Failure to properly open the incomplete case may cause a delay in receiving your deficiency notice.

Debtor's Certification of Completion of Post-petition Instructional course Concerning Personal Financial Management (Official Form 23): ECF users are using the incorrect event code to file Official Form 23. Please use the event code "Financial Management Course" to file this document. If the incorrect event code is used, the case might not be discharged timely and you may be required to re-file.

- 3) The debtor (and debtor's attorney) receive Section 362 orders from the court via the Bankruptcy Noticing Center ("BNC");
- 4) No envelopes or copies for mailing are needed for Section 362 orders, regardless of whether the proposed order is lodged via LOU or at the intake window;
- 5) Requests for special notice are limited, and do not include copies of entered orders;
- 6) "/s/ followed by name" is not acceptable for multiple attorneys on one document; and
- 7) The CM/ECF Administrative Procedures have been updated to specify that "/s/ followed by name" of law firm staff is acceptable on proofs of service.
