#### Incoming Chief Judge and Outgoing Chief Judge



CHIEF JUDGE VINCENT P. ZURZOLO AND FORMER CHIEF JUDGE BARRY RUSSELL

On January 23, 2007 the change of Bankruptcy Court Chief Judge from Judge Barry Russell to Judge Vincent P. Zurzolo was commemorated at the Passing of the Gavel Ceremony in Pasadena. The United States Court of Appeals hosted the ceremony in its beautiful courthouse - formerly a hotel and resort. Approximately 240 people attended the festive event.

After Clerk of Court Jon D. Ceretto officially commenced the ceremony, Chief Judge Zurzolo thanked Judge Barry Russell and introduced the numerous other judges in attendance. Following Chief Judge Zurzolo's remarks, several judges applauded Judge Russell for his accomplishments and congratulated the new Chief Judge including Mary M. Schroeder, Chief Judge of the U.S. Court of Appeals for the Ninth Circuit, Senior Judge Dorothy W. Nelson, also of the United States Court of Appeals for the Ninth Circuit, and Bankruptcy Court Judge Robin L. Riblet.

Following the judges' speeches, Gary E. Stotler of the U.S. District Court, Central District of California formally appointed Chief Judge Zurzolo, an elegant reception followed the ceremony in the courthouse lobby. The Debtor Assistance Project (DAP) is a program of Public Counsel Law Center, the largest *pro bono* law office in the nation. As in years past, the DAP has continued to work closely with the Los Angeles and San Fernando Valley divisions to provide free legal services to qualifying low-income debtors in Los Angeles County. Though the Bankruptcy Abuse Prevention and Consumer Protection Act (BAPCPA) of 2005 has changed the way bankruptcy work is done, it has not reduced the financial pressures that drive at-risk individuals to seek bankruptcy protection. The Debtor Assistance Project seeks to serve these vulnerable populations.

The Project seeks volunteer attorneys who can provide bankruptcy assistance such aspreparation of Chapter 7 petitions, debtor defense in non-dischargeability actions, counseling of *pro se* debtors at reaffirmation hearings, debtor consultations at evening bankruptcy clinics.
