DEBTOR ASSISTANCE PROJECT HOLDS ANNUAL PRO BONO AWARD RECEPTION

On April 17, 2008, the Debtor Assistance Project (DAP) hosted its Annual Pro Bono Award Ceremony. The award ceremony was held to honor members of the bar who helped contribute to the local community with their pro bono work.

Marisa Hawkins, Staff Attorney for Public Counsel Debtor Assistance Project and Consumer Law Project, led with the opening remarks. She was followed by Martin Zohn, of Proskauer Rose and the Vice-Chairman of Public Counsel's Board of Directors, Paul Freese, Public Counsel's Director of Litigation, and the Central District Bankruptcy Court's Chief Judge Vincent Zurzolo.

Judge Zurzolo led the presentation of the William J. Lasarow Award for Outstanding Pro Bono Service in Bankruptcy, the DAP's highest honor, by recognizing the contributions of the award recipients. Judge Thomas Donovan presented the award to Faye Barta, while Judge Maureen Tighe presented to Henry Toles, which was accepted by James King.

Faye Barta was recognized for her longtime volunteer work offering assistance to *pro se* debtors at reaffirmation hearings in the San Fernando Valley division. Henry Toles was recognized for giving countless hundreds of hours to pro bono work through the Los Angeles Free Clinic's bankruptcy project and most recently through his participation in the Self-Help Desk project in Woodland Hills.

The DAP is a program of Public Counsel Law Center, the largest pro bono law office in the nation. As in the past, the DAP has continued to work closely with the Los Angeles and San Fernando Valley divisions to provide free legal services to

qualifying low income debtors in Los Angeles County. The Project seeks volunteer attorneys who can provide bankruptcy assistance such as preparation of Chapter 7 petitions, debtor defense in non-dischargeability actions, counseling of *pro* se debtors at reaffirmation hearings, debtor consultations at evening bankruptcy clinics. BANKRUPTCY FILINGS IN THE FIRST QUARTER OF FISCAL YEAR 2008 HIGHEST IN THE NATION

The Central District of California led the nation by receiving 10,481 filings during the first quarter of fiscal year 2008. The number of filings represented an increase of 89% over the first quarter in 2007. Approximately two-thirds of the district's filings occured in the Los Angeles (36%) and Riverside (28%) divisions.



Overall, bankruptcy filings district-wide rose 91% in 2007, from 17,802 to 34,028, and outpaced the national average by 53%. Filings continue to rebound from a 79% drop in 2006, which was the first full 12-month period subsequent to the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005 (BAPCPA).

THE SAN FERNANDO VALLEY SELF-HELP DESK OFFERS BANKRUPTCY SEMINARS EVERY MONDAY

The San Fernando Valley Self-Help Desk is now offering bankruptcy seminars every Monday from 1:30 pm - 2:30 pm. The seminars will no longer be offered on the first Thursday of each month. In each seminar, a volunteer from the bar will talk about bankruptcy filing requirements and other useful information.

The Self-Help Desk opened on September 17, 2007, to provide *pro* se debtors with access to bankruptcy information, forms, and counsel. CONSENT TO ELECTRONIC NOTICE AND SERVICE OF DOCUMENTS ON U.S. TRUSTEE EFFECTIVE APRIL 1, 2008

The U.S. Trustee recently consented to electronic notice and service on most documents filed with the United States Bankruptcy Court for the Central District of California. This applies in all bankruptcy cases regardless of petition date, and in all adversary proceedings filed on or after April 1, 2008. JUDGE ERNEST M. ROBLES TO PRESIDE OVER RIVERSIDE DIVISION RELIEF FROM STAY MOTIONS

Effective May 1, 2008, Judge Ernest M. Robles will preside over all Relief From Stay motions in chapter 7 and 13 Riverside Division cases assigned to Judge Peter H. Carroll and Judge Meredith A. Jury, except motions to impose/continue the stay under 11 USC § 362(c)(3) and (4).

These changes were announced in **Public Notice 08-008.** The public notice also outlined the following information and procedures for these motions:

Scheduling a Hearing. To schedule Riverside Division Relief From Stay motions on Judge Robles' calendar, refer to Judge Robles' self-calendaring instructions for the Riverside Division on the Court's website at www.cacb.uscourts.gov (select Information> Judge E. Robles > Forms/Instructions/ Procedures/Self-Calendaring).

<u>Delivery of Chambers Copies.</u> A paper copy of Judge Robles' Riverside Division Relief From Stay documents filed through the Court's CM/ ECF system must be immediately delivered (in person or by mail) to the **Intake Section** of the Riverside Division.

<u>Location of Hearings.</u> Judge Robles will hear Riverside Division Relief From Stay motions by telephonic conference unless there are special circumstances that require video hearings. Please consult Judge Robles' instructions on the Court's website at www.cacb.uscourts.gov (select *Information* > Judge E. Robles > Forms/Instructions/ Procedures/Self-Calendaring) for details on appearances and locations.

<u>Submitting Orders.</u> All Riverside Division Relief From Stay Orders for Judge Robles must be submitted electronically through the Court's Lodged Order Upload (LOU) program.
