

BANKRUPTCY COURT HOSTS DISCUSSION GROUPS ON "HOW SHOULD THE LOCAL RULES BE REVISED RELATED TO CHAPTER 7 DEBTOR REPRESENTATION"

On October 22, 2008, Judge Maureen Tighe hosted a "brown bag" discussion group on *How Should the Local Rules be Revised Related to Chapter 7 Debtor Representation* in the Roybal Courthouse. The discussion was held to gather comments and thoughts from the bar on a possible "Rights and Responsibilities Agreement" (RARA) for Chapter 7 Bankruptcy cases (similar to what is now being done for Chapter 13 cases). While no specific proposals or rule changes are currently pending, the Court is interested in Chapter 7 consumer debtor representation issues in the post-BAPCPA era.

CHANGES TO REQUESTS FOR SPECIAL NOTICE AND COURTESY NOTIFICATION OF ELECTRONIC FILING

Since September 15, 2008, the Court has not processed Requests for Special Notices without a reasonable basis in fact and law. All filers of Requests for Special Notices must certify in writing that they have met the above criteria or the request will not be process. For more information on these procedures, please check Public Notice 08-014, which can be found on the Court's Web site www.cacb.uscourts.gov under News/Notices/Publications>Notices>Public Notices.

Additionally, registered CM/ECF users who wish to receive courtesy electronic notification of documents filed in a particular bankruptcy case may now submit a request to the Court using the form "Request for Courtesy Notification of Electronic Filing (NEF)." This form has been made available on the Court's website www.cacb.uscourts.gov under Forms/Rules/General Orders > Court Forms.

All requests made for a courtesy NEF must be filed electronically with the Court and the electronic notifications will be delivered via the Court's CM/ ECF system as an NEF. Notifications will not be delivered by mail, telephone, facsimile, or any other forms of transmission. In addition, requests made at the Intake Window will not be accepted.

CM/ECF Upgrade Postponed

On October 10, 2008, the United States Bankruptcy Court for the Central District of California postponed the upgrade to version 3.2 of CM/ECF. This postponement was attributable to systems performance degradation observed in Court's that recently converted to the news version of CM/ECF. The delayed upgrade to version 3.2 will also postpone the implementation of the Judicial Conference Policy regarding access to transcripts and their redaction. A Public Notice will be posted once the Court is ready to upgrade to version 3.2.

UPCOMING CHANGES TO LOCAL BANKRUPTCY RULES

Local Bankruptcy Rules ("LBRs") changes are coming soon. The Court has undertaken a lengthy and thorough process to revise the LBRs. For example, many provisions from existing LBRs and General Orders have been relocated into existing or new rules to conform to the national numbering system. Other LBRs establish procedures regarding electronic notice and service, or are rewritten for simplicity and clarity. A draft of the LBRs were posted on the Court's website for public comment in August 2008, including a cross-reference of old rule numbers with proposed new numbers. Subsequently, the Board of Judges submitted a draft for District Court approval. Once approved, a Public Notice will be issued to advise of the effective date of the new LBRs.

REMINDER: REQUEST FOR PUBLIC COMMENTS ON PROPOSED AMENDMENTS TO FEDERAL RULES OF BANKRUPTCY PROCEDURE

Now through February 17, 2009, the Judicial Conference's Advisory Committee on Bankruptcy Rules is seeking public comment on proposed amendments to the Federal Rules of Bankruptcy Procedure. The committee is requesting feedback on the new Bankruptcy Rules 1004.2 and 5012, and the amendments to Bankruptcy Rules 1007, 1014, 1015, 1018, 4004, 5009, 7001, and 9001.

CM/ECF TIPS!

Payment of Filing Fees Due at Time of Filing -

The ECF system will automatically lock out a user who has not paid a filing fee when electronic filing a document requiring the fee. Lockout allows the user to login to the ECF system, but access to menus is limited to "Utilities". If you are locked out of the ECF system, click on "Utilities", "Internet Payments Due" and pay any outstanding fees via Pay.Gov. If you suspect you were locked out in error, please call the ECF Support Center at (213) 894-2365.

Reminder to Run the Judge Trustee/Assignment Program-

After opening a new bankruptcy case and **uploading** the Creditors, you must immediately run the Judge/Trustee Assignment Program (under Bankruptcy-BK-Judge/Trustee Assignment) to assign the judge, trustee (if applicable) and 341 meeting date to the case in CM/ECF. Failure to run the Judge/Trustee Assignment program will prevent the creditors and trustee (if applicable) from receiving timely notice of the 341 a Meeting and other events happening in the case.
