

Los Angeles – Roybal Federal Building:

Building Accommodations

- The Temple Street entry is wheelchair accessible. The Terrace Level entry off of the plaza is wheelchair accessible via ramps or paths on either side of the Federal Building at 300 North Los Angeles Street.
- All public restrooms are wheelchair accessible.
- A public telephone device for the deaf (TTY) is available off of the Terrace Street Lobby just outside the cafeteria.
- Smoke detectors and fire alarm systems are equipped with strobe lights.
- Elevator cabs are equipped with braille signage and emergency call features to accommodate those with seeing and hearing impairment.
- ADA intake window available

Santa Ana – Ronald Reagan Federal Building:

Building Accommodations

- The main building entry facing 4th street is wheelchair accessible.
- All individuals seeking entrance to the facility must present a valid, government issued, ID such as a driver's license or state ID and pass through security screening which in most circumstances includes a metal detector. Individuals with pacemakers or cochlear implants may request screening via a handheld wand upon presenting the Court Security Officers with a letter which identifies the condition from the doctor who performed the implant.
- All public restrooms are handicapped accessible.
- A public telephone device for the deaf (TTY) is available. It is located on the second floor immediately inside the United States Bankruptcy Court, Clerk's Office.
- Smoke detectors and fire alarm systems are equipped with strobe lights.
- Elevator cabs are equipped with braille signage and emergency call features to accommodate those with seeing and hearing impairment.
- ADA intake window available

Riverside – George E. Brown, Jr. Federal Building:

Building Accommodations

- The main building entry facing 12th street is wheelchair accessible, via a ramp to the immediate left of the main entry stairs.
- All individuals seeking entrance to the facility must present a valid, government issued, ID such as a driver's license or state ID and pass through security screening which in most circumstances includes a metal detector. However individuals with pacemakers or cochlear implants may request screening via a hand held wand upon presenting the Court Security Officers with a letter which identifies the condition from the doctor who performed the implant.
- All public restrooms are handicapped accessible.
- Smoke detectors and fire alarm systems are equipped with strobe lights.

- Elevator cabs are equipped with braille signage and emergency call features to accommodate those with seeing and hearing impairment.
- ADA Intake window available.
- Courtrooms are ADA accessible - ramps to the bench, witness stands and front row of jury boxes are ground level.
