ORDER SANCTIONING ATTILIO REGOLO, SBN 140964 FOR FAILING TO COMPLY WITH GENERAL ORDER 06-03 AND LOCAL BANKRUPTCY RULE 5005-4:

(1) A PAST MONETARY SANCTION IS NOT IMPOSED ON ATTILIO REGOLO;

(2) A CONTINUING SANCTION IS IMPOSED ON ATTILIO REGOLO OF \$50 PER DOCUMENT FILED OTHER THAN ELECTRONICALLY VIA CM/ECF AFTER JULY 1, 2010;

(3) BARRING ATTILIO REGOLO FROM PRACTICE IN THE UNITED STATES BANKRUPTCY COURT FOR THE CENTRAL DISTRICT OF CALIFORNIA, EFFECTIVE UPON THE DATE OF ENTRY OF THIS ORDER; and

(4) REFERRING ATTILIO REGOLO TO THE STATE BAR OF CALIFORNIA FOR POSSIBLE FURTHER INVESTIGATION AND DISCIPLINE

On July 13, 2010, a hearing ("Hearing") was held on an Order to Show Cause ("OSC") because attorney **ATTILIO REGOLO, SBN 140964**, was not in compliance with the mandatory electronic filing requirements of General Order 06-03 and Local Bankruptcy Rule 5005-4. No appearance was made by of

ATTILIO REGOLO, and no written response to the OSC was filed.

Based upon the findings and conclusions made at the Hearing, **IT IS ORDERED THAT:**

- (1) Cause has not been shown;
- (2) A current monetary sanction is not imposed on **ATTILIO REGOLO**;
- (3) A continuing sanction is imposed on **ATTILIO REGOLO** of \$50 per document filed manually after July 1, 2010, including in person at an intake window or by mail, except as authorized by Local Bankruptcy Rules or the Court Manual or filed in this miscellaneous proceeding;
- (4) **ATTILIO REGOLO** is barred from practice in the United States Bankruptcy Court for the Central District of California, effective upon the date of entry of this order;
- (5) The Clerk of Court must transmit a copy of this order to the California State Bar for possible further investigation and discipline of **ATTILIO REGOLO**; and
- (6) The Clerk of Court must post a copy of this order on this court's website to be viewable by the public.
