20 Sanctions Should Not Be Imposed Against Victor H. Toscano, State Bar No. 80753, For Failing
21 To Comply With General Order 06-03 and Local Bankruptcy Rule 5005-4 ("OSC") dated
22 August 1, 2011. Appearances were stated on the record. Based upon findings of fact and
23 conclusions of law stated on the record pursuant to F.R.Civ.P. 52(a)(1), as incorporated into

1 ORDERED that Toscano must file an ex parte application for reinstatement, supported by
2 a declaration establishing compliance with the terms of this order, to terminate this suspension
3 and to resume practicing before the United States Bankruptcy Court for the Central District of
4 California. A proposed order granting reinstatement must be lodged with the court upon the
5 filing of the application for reinstatement.
