ORDERED that Josserand must file an <u>ex parte</u> application for reinstatement, supported by a declaration establishing compliance with the terms of this order, to terminate this suspension and to resume practicing before the United States Bankruptcy Court for the Central District of California. A proposed order granting reinstatement must be lodged with the court upon the filing of the application for reinstatement.
