20 Sanctions Should Not Be Imposed Against Nicole E. Foster, State Bar No. 275845, For Failing  
21 To Comply With General Order 06-03 and Local Bankruptcy Rule 5005-4 (“OSC”) dated  
22 August 2, 2012. Appearances were stated on the record. Based upon findings of fact and  
23 conclusions of law stated on the record pursuant to F.R.Civ.P. 52(a)(1), as incorporated into  
24 FRBP 7052 and applied to contested matters by FRBP 9014(c), it is

25 ORDERED that Nicole E. Foster, State Bar No. 275845 (“Foster”) is suspended from  
26 practice before the United States Bankruptcy Court for the Central District of California pending  
27 (1) the issuance to Foster of a live ECF log-in and password in compliance with LBR 5005-4;

1 and (2) payment of the sum of \$500.00 in sanctions to the clerk of the court in compensation for  
2 violation of LBR 5005-4 to the date of the OSC; and it is further

3 ORDERED that Foster must file an ex parte application for reinstatement, supported by a  
4 declaration establishing compliance with the terms of this order, to terminate this suspension and  
5 to resume practicing before the United States Bankruptcy Court for the Central District of  
6 California. A proposed order granting reinstatement must be lodged with the court upon the  
7 filing of the application for reinstatement.
