ORDERED that, prior to reinstatement to practice before the United States Bankruptcy Court for the Central District of California, Vargas must file an <u>ex parte</u> application for reinstatement supported by a declaration or other evidence establishing cause for reinstatement, including payment of the sanction amount. A proposed order granting reinstatement must be lodged with the court upon the filing of the application for reinstatement.
