5005-4; and (2) payment of the sum of \$750 in sanctions to the clerk of the court in compensation for violation of LBR 5005-4 to the date of the OSC; and it is further

ORDERED that, prior to reinstatement to practice before the United States Bankruptcy Court for the Central District of California, Villegas must file an ex parte application for reinstatement supported by a declaration or other evidence establishing cause for reinstatement, including payment of the sanction amount and receipt of a live ECF log-in and password in compliance with LBR 5005-4. A proposed order granting reinstatement must be lodged with the court upon the filing of the application for reinstatement.
