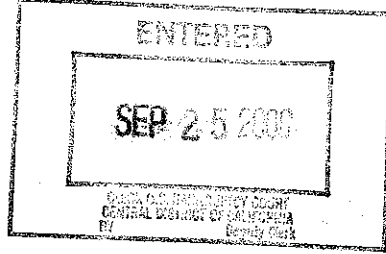
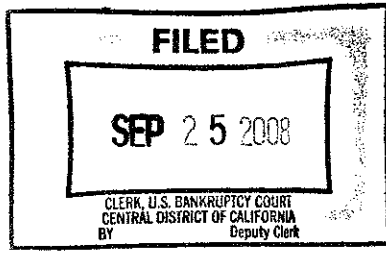

Based on the Memorandum of Disciplinary Proceeding of Sabbir Ahmed and the Stipulation Between Sabbir Ahmed and the United States Trustee Re: Discipline; Order Thereon, filed concurrently herewith (the "Memorandum" and "Stipulation and Disciplinary Order", respectively), it is hereby ORDERED that:

1. The Stipulation Between Sabbir Ahmed and the United States Trustee Re: Discipline shall be and hereby is approved;
2. Mr. Ahmed shall immediately cease practicing in the Bankruptcy Court for the Central District of California until he applies to be, and is in fact, reinstated;
3. Mr. Ahmed is publicly reprovved for failing to adequately supervise non-attorney agents, failing to perform services with


1 competence, and aiding non-attorneys in the unauthorized practice

8 either the Legal Aid Foundation of Los Angeles or Public Counsel;




