Disciplinary Proceeding

On August 29, 2012 Judge Meredith Jury referred Jennifer Urquizu to the disciplinary process of the United States Bankruptcy Court for the Central District of California. In conformance with the Fourth Amended General Order 96-05, the Clerk of Court opened case file 6:12-mp-00101 and selected Judges Brand, Mund, and Robles to serve as the Hearing Panel. Each judge accepted assignment to the Panel.

A review of the electronic case management system shows that Ms. Urquizu has been the attorney of record in 449 bankruptcy cases, the most recent of which was filed on May 10, 2012. In that case she used the address of 3800 Orange St., Ste 220, Riverside, CA 92501, which is the same address as is on the website for the State Bar of California. Her prior business address was 42690 Rio Nedo, Temecula, CA 92590... As shown by the Order Re: Sanctions and Referral to Discipline, Ms. Urquizu has not appeared in the bankruptcy court since early May, 2012.

The Clerk of Court attempted service of the Notice of Assignment of Hearing Panel and the Statement of Cause on Jennifer Urquizu at both addresses. The copy

1	addressed to Orange St. was returned as both "refused" and "addressee unknown."		
2	The one sent to the Rio Nedo address was returned as "not deliverable as addressed,		
3	unable to forward."		
4	The Panel has reviewed the referral and finds that it contains adequate grounds		
5	to impose discipline on Jennifer Urquizu for not providing competent legal service and		
6 7	not complying with previously issued court orders for disgorgement. The panel is also		
8	concerned that it appears that Ms. Urquizu has abandoned her clients and has misused		
9	a client's credit card.
