MEMORANDUM OF DECISION IN DISCIPLINARY PROCEEDING AGAINST JUAN J. GONZALEZ

The matter before the court is a disciplinary proceeding ("Proceeding") commenced against attorney Juan J. Gonzalez ("Gonzalez") pursuant to Fourth Amended General Order 96-05 of the United States Bankruptcy Court for the Central District of California (the "General Order").

Statement of Procedure and Notice of Hearing

Pursuant to that certain Order to Show Cause entered on September 11, 2013, by

bankruptcy judge Theodor C. Albert, in In re Joel Gonzalez Castillo and Maria Magdalena Gonzalez, chapter 13 case no. SA 13-12282 TA (the "Castillo Case"), a hearing ("OSC Hearing") was held on October 8, 2013 to show cause why Juan J. Gonzalez should not be referred to State Bar and Disciplinary Panel of the Bankruptcy Court for further disciplinary action regarding "Attorney's Documents filed in Violation Status (from 5/16/13 to 5/31/13)." Mr. Gonzalez failed to appear at the OSC hearing, and on October 29, 2013, the Bankruptcy Court entered its Order Regarding Hearing On Order To Show Cause Why Debtor's Attorney, Juan J. Gonzalez, Should Not Be Referred To The State Bar And Disciplinary Panel Of The Bankruptcy Court For Further Disciplinary Action entered October 29, 2013 (the "Referral Order"). Pursuant to the Referral Order and that certain "Referral of Attorney Juan Jose Gonzalez to the United States Bankruptcy Court Disciplinary Panel Committee" from Judge Albert to the Bankruptcy Court Clerk of Court dated January 23, 2014 ("Statement of Cause"), the Proceeding was referred to a disciplinary panel established under the General Order.

In accordance with the procedure set forth in the General Order, the Clerk of the Bankruptcy Court designated a panel of three bankruptcy judges from this district to hear the Proceeding. The members of the panel are the Hon. Alan M. Ahart, the Hon. Catherine E. Bauer, and the Hon. Mark Houle (collectively, the "Panel"). A Notice of Assignment of Hearing Panel, the General Order, and Statement of Cause (with Referral Order attached thereto) were served on Mr. Gonzalez on February 6, 2014. Pursuant to the General Order, Mr. Gonzalez had until the expiration of a period of 14 days after service of the foregoing notice to move to recuse one or more of the judges assigned to the Panel. No motion to recuse was filed.

Pursuant to that Amended Notice of Disciplinary Hearing served on February 28, 2014,

Mr. Gonzalez was given notice of the attorney disciplinary hearing to be held before the Panel on

March 31, 2014, at 10:00 a.m. ("Disciplinary Hearing"). He did not file a written response of any kind or appear at the Disciplinary Hearing.

Referral to the Panel Pursuant to General Order No. 96-05

The conduct that gave rise to the referral to the Panel is set forth in the attached Statement of Cause, which contains a thorough discussion of Mr. Gonzalez's practice and actions at issue, as well as copies of relevant documents including State Bar records and docket reports. In summary, Mr. Gonzalez continued to practice law after the State Bar declared him "Not Eligible to Practice Law" on May 10, 2013.

First, in the Castillo Case, on July 17, 2013, after commencing the case as attorney of record for the debtor and subsequently being declared ineligible to practice law, a Substitution of Attorney form was filed bringing in another attorney, John Vargas, who had at the relevant time the same address as suspended attorney Juan J. Gonzalez. The State Bar records, however, reflect that John Vargas had also been declared "Not Eligible to Practice Law" on July 2, 2013. In particular, several docket entries in the Castillo Case reflect that Mr. Gonzalez filed the following docket entries with the Court after his ineligibility date of May 10, 2013: docket nos. 24, 25, 26 and also perhaps 30 and 35.

Second, in the bankruptcy case captioned <u>In re Tony Khoa Vo and Gabriela Deyanira Vo</u>, case no. 13-13995, the docket shows that Mr. Gonzalez apparently filed two docket entries after his ineligibility date of May 10, 2013: docket nos. 10 and 11.

Based on the foregoing actions of Mr. Gonzalez, by the Statement of Cause, among other things, the bankruptcy court recommended that Mr. Gonzalez be barred from appearing in Bankruptcy Court or utilizing electronic filing privileges for the duration of his suspension by the State Bar, and should be required to participate in an appropriate ethics seminar or tutorial.

Finally, the Panel notes that, pursuant to Business and Professions Code Section 6007, the State Bar of California involuntarily inactively enrolled Juan J. Gonzalez effective April 5, 2014.

The Hearing

The Disciplinary Hearing regarding Gonzalez was held before the Panel on March 31, 2014. Mr. Gonzalez did not appear (nor were there any other appearances) or file a written response of any kind.

Findings

Based on the Referral Order and the allegations of the Statement of Cause, as well as Mr. Gonzalez's failure to file a written response or appear at the Disciplinary Hearing, the Panel concludes that Juan J. Gonzalez should be suspended indefinitely from practicing before the United States Bankruptcy Court for the Central District of California, including prohibiting Mr. Gonzalez from utilizing electronic CM/ECF filing privileges, effective as of the entry date of the Order on Disciplinary Proceeding of Juan J. Gonzalez entered concurrently herewith. Mr. Gonzalez may apply for reinstatement to practice before the bankruptcy court in accordance with the provisions of the General Order. Without limitation to other conditions that may be imposed upon Mr. Gonzalez in connection with prospective reinstatement, Mr. Gonzalez is ordered to complete fifteen (15) hours of continuing legal education in the subject of legal ethics offered by a provider of continuing legal education recognized by the State Bar of California, and submit written proof of completion thereof, before he may be reinstated to practice before the United States Bankruptcy Court for the Central District of California.



Gentlepersons:

I hereby refer Attorney Juan Jose Gonzalez to the Bankruptcy Court Disciplinary Panel Committee. My referral Order filed on October 29, 2013, #49 on the Court's docket in the Castillo matter is attached. I also enclose the dockets in the both the Castillo matter and in the In re Tony Khoa Vo and Gabriela Deyanira Vo matter. Juan Jose Gonzalez, State Bar No. 243647, in two cases assigned to me, apparently continued to practice law after he was declared "Not Eligible to Practice Law" by the State Bar on May 10, 2013. The State Bar's records indicating "Discipline w/actual suspension," Case Number, 11-O-18560, are enclosed, along with the other pertinent documents, including the dockets, on these two matters.

in Castillo, on July 17, 2013, a Substitution of Attorney form was filed bringing in another attorney, John Vargas, who has the same address as the suspended attorney, Juan J. Gonzalez. Further search of the State Bar's records (also attached), shows the new attorney, John Vargas, was also "Not Eligible to Practice Law" on July 2, 2013. At the OSC hearing on October 8, 2013 at 11:00 a.m. (calendar sheet attached), there was no appearance by either John Vargas or Juan Jose Gonzalez in the Castillo matter. There are several docket entries in which Attorney Gonzalez apparently continued to file documents with the Court. Attorney Gonzalez filed the following documents on the Court's docket after his ineligibility date of May 10, 2013: #24, #25, #26, perhaps #30, #35 (docket attached). Attorney John Vargas, who was also ineligible to practice on July 2, 2013, filed documents in this case after his ineligibility date of July 2, 2013: #31, #34, #40, #41.

Mr. Gonzalez also filed the Chapter 7 Case in *In re Tony Khao Vo and Gabriela Deyaniara Vo* on May 4, 2013, but he was deemed "Not Eligible to Practice Law" on May 10, 2013, less than a week later. Attorney Gonzalez filed #10 on the Court's docket after his May 20, 2013 suspension. Both Debtors were discharged in this case on August 12, 2013.

Given his suspension by the State Bar, at a minimum, I would recommend that the Disciplinary Panel Committee find:

- (1) Both the Castillo and the Vo matters should be consolidated so they can both be heard together at one Disciplinary Panel Committee meeting;
- (2) Attorney Gonzalez should be precluded for the duration of his suspension from appearing in Bankruptcy Court or utilizing electronic filing privileges;
- (3) Attorney Gonzalez should be required to participate in an appropriate ethics seminar or tutorial; and
- (4) Explain whether he also was involved in promoting the unlicensed practice of law by substituting attorney John Vargas in the Castillo matter.

May 10, 2013

JUAN JOSE GONZALEZ [#243647], 33, of Santa Ana was suspended for two years, stayed, and placed on three years of suspension with an actual two-year suspension and until he shows evidence of rehabilitation and fitness to practice law. Gonzalez must also take the MPRE, comply with rule 9.20 of the California Rules of Court and pay restitution. The order took effect May 10, 2013.

Gonzalez stipulated to 20 acts of misconduct in six cases, many of which involved financially distressed clients for whom he did little or no work. They include aiding an employee in the unauthorized practice of law, failing to refund unearned fees, failing to promptly return a client's file, disobeying a court order and making a false representation to the State Bar.

Gonzalez was ordered to pay \$11,225 in restitution, plus interest.


