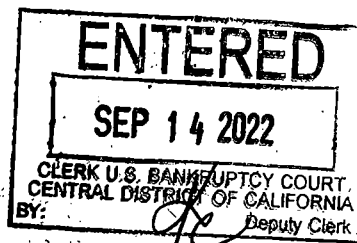
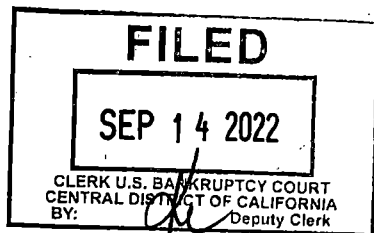


The Court further orders as follows:
