

CATING NOVEMBER 9, 2009 ORDER SUSPENDING BRIAN D. WIRSCHING [sic] FROM PRACTICING LAW IN THIS COURT

Having considered the Application for Reinstatement of Privileges ("Application") filed by attorney Brian D. Wirsching ("Wirsching") with his accompanying Declaration, filed on September 9, 2013, Chief Judge Peter H. Carroll, as the representative of the Attorney Disciplinary Hearing Panel ("Panel") that entered the Order Suspending Brian D. Wirshing [sic] from Practicing Law in this Court on November 9, 2009 ("Suspension Order"), hereby grants the Application and vacates the Suspension Order.

The Panel further orders as follows:

- 1. Wirsching is hereby reinstated to the practice of law before the Bankruptcy Court for the Central District of California, effective immediately.
- 4. This Panel retains jurisdiction to enforce the terms and conditions of this Order, the Suspension Order, or any other order entered in the above referenced disciplinary proceeding, as well as to hear and determine any applications for other or further discipline against Wirsching
