

## Petition Preparation Software with CM/ECF Case Data Upload Functionality

Although generic word processing software (e.g., WordPerfect, Microsoft Word, etc.) may be used to create documents, there are many software packages on the market which create bankruptcy forms and simplify the creation of petitions and other pleadings. They may also simplify the conversion of documents to PDF format. These software packages are particularly helpful to attorneys who intend to file new cases.

Listed are the bankruptcy petition software vendors that developed speciality software for bankruptcy forms preparation. In addition, some have modified their software to allow for automatic case upload from their application into CM/ECF. This list is posted for informational purposes only.
