1 Report). Said Status Report is to address the following issues
2 specifically:

- 3 • Status of any contemplated disclosure statement and
4 plan, and an estimate when these will be filed;
- 5 • Whether the Debtor has performed all of its duties under
6 11 U.S.C. §§ 521, 1106 and 1107;
- 7 • The post-petition operations of the Debtor and the
8 status of reorganization efforts;
- 9 • Whether any professionals have been retained by the
10 Debtor upon approval of the Court, and if no such approval
11 was obtained, the reason why approval was not obtained;
12 and it is further,

13 ORDERED: That on XXXXXXXXXXXX at XXXX, in Courtroom 1568
14 the Court will conduct a hearing on the Status Report; and it is
15 further,

16 ORDERED: That, absent good cause, failure of the Debtor
17 to file and serve the Status Report and appear at the hearing on the
18 Status Report will be grounds sufficient to dismiss, convert or appoint
19 a chapter 11 trustee in this case; and it is further,

20 ORDERED: That at the hearing on the Status Report, in
21 addition to dismissing, converting or appointing a chapter 11 trustee,
22 the Court may set deadlines for entry of an order approving a
23 disclosure statement and entry of an order confirming a plan, or other
24 orders which the Court deems appropriate under the circumstances.
