Overbid Procedures: While the Trustee is prepared to consummate the sale with the Purchasers, Trustee is also interested in obtaining the maximum price for the Property. Therefore, the Trustee seeks approval of the following overbid procedures: (1) any person interested in submitting an overbid on the Property must attend the hearing on the Motion or be represented by an individual with written authority to participate in the overbid process; (2) an overbid will be defined as an initial overbid of \$1,000 above the Purchase Price, with each additional bid in increments of at least \$1,000; (3) overbidders (except for the Purchasers) must deliver a deposit to the Trustee by way of cashier's check made payable to "Todd Frealy, Chapter 7 Trustee" in the amount of \$450 (the "Deposit") and proof of ability to close escrow unconditionally in a form acceptable to the Trustee **prior to the hearing on the Motion**; (4) overbidders must purchase the Property on the same terms and conditions as the Purchasers, and, if successful, will be required to execute a purchase agreement with no contingencies, with the same terms and conditions that Purchasers currently have in escrow; (5) the Deposit of the successful overbidder shall be forfeited if such party is thereafter unable to complete the purchase of the Property within 15 calendar days of entry of an order confirming the sale; and (6) in the event the successful overbidder cannot timely complete the purchase of the Property, the Trustee shall be authorized to proceed with the sale to the next highest overbidder (as applicable).
