Bidding Procedures

Set forth below are the proposed bidding procedures (the "Bidding Procedures") to be employed with respect to the prospective sale by Lytton Vineyard & Winery, L.P. (the "Seller"), as the debtor and debtor-in-possession in its chapter 11 bankruptcy case, Case No. 1:24-bk-11748-VK, of the real property commonly known as 34567 Rancho California Rd., Temecula, CA 92592 and related personal property consisting of inventory and equipment (the "Property"), free and clear of all liens, claims, interests, and encumbrances.

Seller has entered into a purchase and sale agreement (the "PSA") for the purchase and sale of the Property to Robert Renzoni or assignee (the "Proposed Buyer"). Seller will seek entry of an order by the United States Bankruptcy Court (the "Bankruptcy Court"), among other things, authorizing and approving the sale to the Proposed Buyer or to a Qualified Bidder (as hereinafter defined) which the Bankruptcy Court may determine to have made the highest or otherwise best offer to purchase the Property (the "Successful Bidder").

The Bidding Process

- (a) An Overbid offer to purchase the Property of at least twelve million three hundred thousand dollars (\$12,300,000.00) in cash consideration;
- (b) A proposed PSA similar to the terms set forth in the Proposed Buyer's PSA with changes identified via a red-lined document such that all proposed changes are highlighted for the Court and interested parties;
- (c) Statement that the Overbid is irrevocable until three (3) business days after the date of the Auction unless such Overbid is designated as the winning bid or Back-up Bid (as hereinafter defined), in which case the bid shall be irrevocable until the sale of the Property has closed;
- (d) Statement that the Overbid is not conditioned on obtaining financing, regulatory contingencies, any internal approval or on the outcome or review of due diligence;
- (e) Written evidence of a firm commitment for financing or other evidence of the financial wherewithal of such Qualified Bidder that the Seller reasonably believes in its sole

- discretion, provides the ability to consummate the sale with appropriate contact information for such financing sources;
- (f) An Overbid deposit ("Overbid Deposit") in the amount of not less than of three hundred sixty thousand (\$360,000.00), which will be non-refundable if the Qualified Bidder is the Successful Bidder at the conclusion of the Auction and the sale does not close due to the Qualified Bidder's default. The Overbid Deposit must be actually received by the Debtor or its designated escrow company by the Overbid Deadline; and
- (g) If the Overbidder is not the Successful Bidder, the Seller will return the Overbidder's Overbid Deposit within three (3) business days after the auction date. Notwithstanding the foregoing, if the Overbidder is not the Successful Bidder but nevertheless agrees on the record to be a Back-up Bidder, such Back-up Bidder's deposit will not be immediately returned after the auction and will instead be held by Seller until the sale closes and returned within three (3) business days of such closing.

Designation as Qualified Bidder

A "Qualified Bidder" is a bidder that the Seller determines has submitted by the Overbid Deadline a *bona fide* offer consistent with the foregoing Overbidder Qualification Requirements that would result in greater value than the value that the Seller would receive under the PSA and be able to consummate a sale if selected as a Successful Bidder.

Bid Protection

Subject to Bankruptcy Court approval, Proposed Buyer shall be entitled to be paid break-up fee in the amount of two hundred fifty thousand dollars (\$250,000.00) ("Break-Up Fee") if a higher or otherwise better offer from another bidder results in a closed sale of all or substantially all of the Property to any person (including the Proposed Buyer or a designee of Proposed Buyer) at a price equal to or greater than twelve million three hundred thousand dollars (\$12,300,000.00) (the "Alternative Transaction") and the Proposed Buyer was not in default of any of its obligations under the PSA and was otherwise ready, willing and able to close a sale for the Property. This Break-Up Fee has been negotiated between the Seller and the Proposed Buyer and is designed to compensate the Proposed Buyer for the time and effort it has put into this transaction as well as to obtain a release of all claims of the Proposed Buyer against Seller related to the fact that the Proposed Buyer agreed pre-petition and in fact did release \$85,000 to Seller pre-petition in order to fund Seller's payroll. Payment of the Break-Up Fee shall be subject to the closing of the Alternative Transaction and, if approved by the Court, paid from the sale proceeds within five (5) business days of the closing of the Alternative Transaction.

Bidding at Auction

If at least one Qualified Bidder who has submitted an Overbid appears at the Auction, the Seller shall designate what it determines, in its reasonable judgment, to be the best and highest Overbid received for the Property to be the leading bid at the Auction. Thereafter, the Seller shall solicit better and higher bids for the Property from the Qualified Bidders participating in the Auction (including the Proposed Buyer, if it chooses to participate) until the best and highest bid for the Property has been determined by the Seller (the "Successful Bid"). Any Overbid(s) must be in increments of at least ten thousand dollars (\$10,000). The qualified bidder who submits the second best/highest bid for the Property at the Auction shall be designated as the back-up bidder (the "Back-up Bidder" and his/her/its bid a "Back-up Bid"), if such bidder consents to act as the backup bidder. In the event that Proposed Buyer or the Successful Bidder cannot timely complete

the purchase of the Property, the Seller shall be authorized to proceed with the sale of the Property to the Back-up Bidder without further notice, hearing or order of the Bankruptcy Court.

Auction and Sale Hearing

After all Qualified Bid(s) have been received, the Seller shall conduct an auction (the "Auction") for the Property. Such Auction shall take place in Courtroom 301¹ of the Bankruptcy Court, San Fernando Valley Division located at 2104¹ Burbank Boulevard, Woodland Hills, CA 91367 on December 18, 2024, commencing at 1:30 a.m. (Pacific Standard time). Unless otherwise ordered by the Court, only a Qualified Bidder who has submitted a Qualified Bid and the Proposed Buyer will be eligible to participate at the Auction. At such Auction, the Proposed Buyer and Qualified Bidders will be permitted to increase their bids.

The sale hearing (the "Sale Hearing") shall take place immediately following the Auction at the Bankruptcy Court. The Sale Hearing may be adjourned or rescheduled without notice by an announcement of the adjourned date of the Sale Hearing. At such Sale Hearing, Seller shall present the Successful Bid to the Bankruptcy Court for approval.

Acceptance of Qualified Bids

Seller presently intends to sell the Property to Proposed Buyer or the highest or otherwise best Qualified Bidder.
