

- 1. This court has subject matter jurisdiction over Belair & Evans LLP's ("Belair") counter-claim against Kathyrn T. McGuigan, pursuant to 28 U.S.C. 1334(b), in that this counter-claim constitutes a core proceeding, or, alternatively, is related to the administration of the Sizzler bankruptcy estate.
- 2. The court is precluded from exercising its discretion to abstain 7 from adjudicating Belair's counter-claim pursuant U.S.C. $8 \parallel 1334(c)(1)$, as there is no pending state court action.
- 3. Belair shall be given twenty days (20) from the date of entry of 10 this order to file and serve a Notice of Withdrawal of its motion to dismiss the counterclaim without prejudice.
- In the event Belair does not timely file and serve its Notice of Withdrawal, the counterclaim is dismissed with prejudice, the court granting McGuigan's request to dismiss with prejudice the counterclaim, 15 Belair's motion to dismiss without prejudice is denied.
 - In the event that Belair timely files a Notice of Withdrawal, the court will set a further status conference hearing regarding Belair's prosecution of its counter-claim, and at that time will set new dates for hearing on McGuigan's motion for summary judgment and request to file a third party complaint.
