MOTION FOR DEFAULT JUDGMENT AS  
MOOT AND DISCHARGING ORDER TO  
SHOW CAUSE**

A hearing on the Motion for Default Judgment filed by Plaintiff Kiran Patel was conducted before the undersigned United States Bankruptcy Judge on October 28, 2014. Lorne Lilienthal of the law firm of Regan & Associates appeared on behalf of Plaintiff. No appearance was made on behalf of Defendant.

Having reviewed and considered the complaint in this adversary proceeding and the moving papers and for the reasons stated on the record, it is hereby ordered that this case is dismissed without prejudice based on the federal jurisdictional limitation of lack of case or controversy in that the complaint objects to the discharge of a debtor, which is a

1 corporation ineligible for a discharge in a Chapter 7 bankruptcy case because it is not an  
2 individual pursuant to 11 U.S.C. § 727(a)(1), and that the motion for default judgment is  
3 denied as moot. Fed. R. Bankr. P. 7012; Fed. R. Civ. P. 12(b)(1); *see also*, U.S.  
4 Constitution, Article III, § 2; 1 Schwarzer, Tashima and Wagstaffe, *California Practice*  
5 *Guide: Federal Civil Procedure Before Trial*, ¶ 2:4101 at 2E-1 (2014).

6 It is further ordered that the court's order to show cause regarding sanctions for  
7 failure to appear at a status conference and to file a status report as required by Local  
8 Bankruptcy Rule 7016-1 set for November 18, 2014 at 2:30 p.m., in this adversary  
9 proceeding is hereby discharged, that the hearing on the order to show cause is vacated  
10 and that no appearances are necessary on November 18, 2014.
