The court has received the order entered March 12, 2015, by the Bankruptcy Appellate Panel (BAP) granting a limited remand to this court of Plaintiff John Lebrun's timely January 27, 2015 notice of appeal to the BAP. This remand was granted, as stated by the BAP, to allow the bankruptcy court "to take whatever action . . . [it] sees fit" in reconsidering this court's January 15, 2015 order appealed to the BAP. Therefore, this court now sets this matter for hearing on April 22, 2015, at 10:00 a.m., in courtroom 1345, as follows:

- 1. The court will consider at the above-stated hearing whether to vacate its January 15, 2015 order dismissing the foregoing adversary proceeding, reinstating this adversary proceeding on the court's docket, and setting this matter for a status conference hearing.
- 2. Any opposition to such reconsideration, as requested in Plaintiff's Motion for Reconsideration filed and served January 15, 2015, shall be filed in writing and served not later than April 8, 2015.
- 3. Both Plaintiff John Lebrun and his attorney Zakeya Leona Brookins are directed to appear at such hearing in person.
- 4. Any reply papers shall be filed in writing and served not later than April 15, 2015, with copies served directly on Plaintiff.
- 5. The court will also consider at the hearing whether attorney Brookins should (a) be substituted out of this matter; (b) be directed to return to Plaintiff any retainer or fee received in this matter; (c) have any contingent fee arrangement between Plaintiff and Brookins deemed cancelled and of no further effect; and further, (d) why this court should not refer Brookins' conduct in this matter, as noted in the court's March 11, 2015 order, to the State Bar of California for further investigation and prosecution for Brookins' inexcusable neglect of Plaintiff's interest in this matter.
- 6. Attorney Brookins is directed to serve immediately upon Plaintiff Lebrun at his usual address (e) this order and (f) the order entered previously by this court on March 11, 2015.
- 7. Attorney Brookins is directed to promptly file proof that she served both orders upon Lebrun.
