- 7 1. The Stipulation is APPROVED;
- 8 2. The Applicant’s Fee Application, which sought \$341,308.73 in fees and \$3,282.50 in  
9 costs, is reduced by \$14,336.55 in fees;
- 10 3. A hearing is currently scheduled on June 12, 2024, at 10:00 a.m. for the Court to  
11 consider and rule on the Application; and
- 12 4. The Parties shall bear their own fees and costs associated with the negotiation and  
13 preparation of the Stipulation.
