## LASAROW AWARDS HONOR SELF-HELP DESK VOLUNTEERS IN CENTRAL DISTRICT

On Thursday, December 3, Public Counsel hosted its 2015 William J. Lasarow Awards in the lobby of the Edward R. Roybal Federal Building and U.S. Courthouse in Los Angeles. Public Counsel holds the annual awards and reception to recognize volunteers serving the *pro se* bankruptcy population throughout the Central District. Senior Staff Attorney Magdalena Reyes Bordeaux opened the ceremony, thanking the volunteers for their service and highlighting the way the Central District is used as a model for self-help programs across the country.

The Court continues to be among the bankruptcy courts with the highest number of filings in the nation, projecting slightly above 46,000 filings through December for the 2015 calendar year. This year, the total number of *pro se* debtors in the district was over 10,780, based on local court data collected through November 2015. Despite a general decrease in the number of filings nationwide, the number of *pro se* filings in the Central District remains at nearly a quarter of the total filings, underscoring the benefit to the Court, in addition to the public, achieved by the service of *pro bono* volunteers. In her remarks, Chief Judge Bluebond noted that the national average of *pro se* filers is only 9 percent.

Retired Judge William J. Lasarow was among more than 65 guests in attendance, including Chief Bankruptcy Judge Sheri Bluebond and Bankruptcy Judges Catherine E. Bauer, Thomas B. Donovan, Sandra R. Klein, Robert N. Kwan, Victoria S. Kaufman, Scott H. Yun and Vincent P. Zurzolo. After a moment of silence in remembrance of the victims of the shooting that had taken place in San Bernardino one

day earlier, Judge Zurzolo also spoke. He talked about the need to show compassion and love as the best response to a tragic event, and said that the work of *pro bono* attorneys was a fitting example of “showing compassion and love” to the community. He also praised the partnership between the Court and its *pro bono* community, based on a shared commitment to serving the population of the Central District.

Each of the five organizations operating Self-Help Desks district-wide honored an outstanding volunteer for 2015. The honorees were: for Public Counsel in Los Angeles, W. Sloan Youkstetter; for the Legal Aid Foundation of Santa Barbara County in the Northern Division, Uchechi Egeonuigwe; for the Public Service Law Corporation in the Riverside Division, Ruben Escalante; for Public Law Center in Santa Ana, Philip Metzinger; and for Neighborhood Legal Services of Los Angeles County in the San Fernando Valley, Gail Higgins. ## REVISED LOCAL BANKRUPTCY RULES EFFECTIVE JANUARY 4

The Board of Judges has approved the following revised Local Bankruptcy Rules that will become effective on January 4, 2016:

- LBR 2016-2: chapter 7 trustee disbursements.
- LBR 2090-1: limited scope of representation.
- LBR 3015-1: chapter 13 trustee distributions upon conversion/dismissal.
- LBR 9013-1: express or implied consent to Bankruptcy Court’s entry of final order or judgment.
- Technical corrections, e.g.: LBR 1000 series, LBR 4001-2, LBR 7000 series, LBR 8000 series, LBR 9000 series.

## JUDICIAL PROFILE OF JUDGE JURY PUBLISHED

The September issue of the Central District Consumer Bankruptcy Attorney Association’s (CDCBAA’s) newsletter features a profile of Judge Meredith A. Jury. The article, coauthored by CDCBAA President Nancy B. Clark and attorney Renee Sawyer Blume, takes an in-depth look at Judge Jury’s career, focusing on her perspective as a woman in professions that have been historically dominated by men. Beginning with the judge’s childhood in Valparaiso, Indiana, where her mother’s observation of the Golden Rule was a formative influence, the profile follows her path to the bench. A *cum laude* and Phi Beta Kappa graduate of the University of Colorado, Judge Jury earned master’s degrees in Economics and Education before enrolling in law school. In 1974, while studying law at UCLA, Judge Jury began working at Best Best & Krieger as a summer law clerk; by 1976, the firm had made her its first female associate. She went on to become the firm’s first female partner and the managing partner of its office in Ontario, California.

It was at Best Best & Krieger that, at the suggestion of her mentor at the firm, Judge Jury learned the new bankruptcy law established by the passage of the Bankruptcy

**When to File a Motion to Reopen a Bankruptcy Case**

A motion to reopen a bankruptcy case should be filed only when the bankruptcy case has been closed. The case docket must be reviewed to verify that the case is closed prior to filing this motion. If the "Motion to Reopen" event code is used to file the document and the case is still open, users will still be required to pay the appropriate filing fee.

**When to File the Debtor's Certification of Completion of Postpetition Instructional Course Concerning Personal Financial Management**

Official Form 423 should be completed and filed only if the financial provider has not already notified the Court of the debtor's completion of the course by filing the certificate. For chapter 7 filings, this form and/or the certificate must be filed within 60 days after the first date set for the meeting of creditors. Additionally, a separate form is required for each debtor. The event code to file this document is located under:

Bankruptcy -> BK - Other -> **Certification about a Financial Management Course for Debtor 1 (Official Form 423)**

Bankruptcy -> BK - Other -> **Certification about a Financial Management Course for Debtor 2 (Official Form 423)**

If this form is not filed within the allotted time period, the clerk will be required to notify the debtor that the case will be closed without entry of a discharge.

Reform Act of 1978. "His recommendation was that I needed a niche," Judge Jury remembers. "I needed something that would make me different than the other litigators at the firm for partnership reasons. So, it was at his recommendation that I learned the new law. I knew more about it the day it became effective than most of the lawyers that had been practicing for a long time. It was a very different law. I appeared in front of Judge David Naugle about ninety percent of the time. And he was happy to have a woman in his courtroom. He recognized that I knew the new law and the other attorneys did not. So, I had a leg up."

Though she says she never planned to be a judge, colleagues encouraged her to apply for judicial appointments in the Inland Empire, first at District Court and then at Bankruptcy Court. The Ninth Circuit appointed Judge Jury to her first term on the bench in November 1997. In the wide-ranging discussion of her judicial career that concludes the profile, Judge Jury discusses making the transition from representing creditors and trustees to adjudicating cases; her pragmatic approach to chapter 13s; the City of San Bernardino's ongoing chapter 9 case; being the senior bankruptcy judge in the Riverside Division; and the importance of family.

## **JUDGES CLARKSON AND BARASH PARTICIPATE IN ABI'S WINTER LEADERSHIP CONFERENCE**

The American Bankruptcy Institute held the 27<sup>th</sup> Annual Winter Leadership Conference in Phoenix, Arizona from Thursday, December 3 through Saturday, December 5. On Friday afternoon, Judges Clarkson and Barash took part in the "Supreme Court Round-Up." During this "round and round" program, 11 bankruptcy judges from across the country visited conference-goers' tables to discuss recent Supreme Court decisions with groups of nine or fewer. On Saturday morning, Judge Barash also sat on the "Judges' Hot Topics" panel.

## **REVISED OFFICIAL BANKRUPTCY FORMS AND NOTICES IMPLEMENTED DECEMBER 1, 2015**

Over 100 revised Official Bankruptcy Forms and notices became effective nationwide December 1, 2015. Implementing a new version of the Court's case management system to accommodate the change was a huge undertaking for the Clerk's Office; it impacted chambers, Operations, Information Technology, Communications, and the public. The Clerk's Office began issuing multiple email blasts to ECF filers, posted two public notices and posted a webpage with information in advance so that attorneys, trustees, forms software providers, and other members of the public could prepare for December 1. The Court's webpages contain [new petition packages](#), revisions to [section two of the Court Manual](#) on requirements for case commencement documents, and a [video overview with links to additional information](#). Technical glitches in CM/ECF during the live implementation were few and were quickly resolved. Clerk's Office staff will issue deficiency notices when outdated case commencement forms are filed on or after December 1, 2015. Check with your software provider to ensure you are filing the current versions of the forms.
