COURT HOSTS ROADWAYS TO THE FEDERAL BENCH: WHO ME? A BANKRUPTCY OR MAGISTRATE JUDGE?

On April 3, 2023, the Court, in conjunction with the Judicial Conference Committees on the Administration of the Bankruptcy System and the Magistrate Judges System, hosted an event for lawyers and law students called "Roadways to the Federal Bench: Who Me? A Bankruptcy Judge or Magistrate Judge?" The event, which focused on increasing diversity on the bench, was held simultaneously in 38 cities across the United States and included a panel discussion on a wide range of topics, including the bankruptcy judge and magistrate judge application process, how to succeed as a judge, and the importance of diversity on the bench.

Following the panel discussion, local lawyers, law clerks, and law students participated in roundtable discussions with Ninth Circuit, District, Magistrate, and Bankruptcy judges about pathways to the federal bench. Circuit Judge Jacqueline H. Nguyen participated in the roundtable discussions as did District Judges Dolly M. Gee, John A. Kronstadt, Fernando M. Olguin, and Sunshine S. Sykes; Magistrate Judges Maria A. Audero, Pedro V. Castillo, Patricia Donahue, Margo A. Rocconi, Alicia G. Rosenberg, and Michael R. Wilner; Chief Bankruptcy Judge Theodor C. Albert, and Bankruptcy Judges Martin R. Barash, Neil W. Bason, Sheri Bluebond, Julia W. Brand, Ronald A. Clifford III, Sandra R. Klein, Robert N. Kwan, Magdalena Reyes Bordeaux, and Erithe A. Smith.

Judge Klein thanked and recognized all the judges who participated in the event, as well as the other members of the Central District of California Steering Committee and the Court's staff, whose hard work resulted in a very successful and seamlessly executed event. This is the judiciary's second iteration of a national diversity event for lawyers and law students. The first Roadways program, held in 2019, focused on diversity on the bankruptcy bench.

HIGH SCHOOL STUDENTS CONSIDER THE 28TH AMENDMENT IN ANNUAL CIVICS CONTEST

The U.S. District Court and U.S. Bankruptcy Court for the Central District of California recently hosted a civics contest for high school students in grades nine through twelve (Local Contest), which was held in conjunction with a civics contest sponsored by the Ninth Circuit for high school students in the Western United States (Ninth Circuit Civics Contest). This year's Ninth Circuit Civics Contest "The 28th Amendment to the United States Constitution: What Should Our Next Amendment Be?" challenged students to contemplate and focus on three questions: (1) What amendment would you propose for our Constitution?; (2) Why?; and (3) How would you get your amendment ratified?

The first-, second-, and third-place winners received cash prizes. Each year, the top essays and videos in the Central District's contest advance to the Ninth Circuit Civics Contest to compete with the essay and video winners from all the other districts in the Ninth Circuit. In addition to cash prizes, first place winners of the Local Contest and a parent/guardian are invited to attend the 2023 Ninth Circuit Judicial Conference. The Ninth Circuit Contest is sponsored by the Ninth Circuit's Public Information and Community Outreach (PICO) Committee, the U.S. Court of Appeals for the Ninth Circuit. In all, the U.S. District and Bankruptcy Courts in the 15 judicial districts that comprise the Ninth Circuit. In all, the Ninth Circuit Contest received 966 essays and 86 videos this year. 

BANKRUPTCY FRAUD PROSECUTIONS

The following information has been provided by the Office of the United States Trustee:

People of the State of California v. Robert Sedlar

Robert Sedlar, the former president of Grand View Financial, LLC, was found guilty by a state-court jury on May 12, 2023, of 100 felony counts relating to the operation of a mortgage fraud rescue scheme operated in multiple states including California. Sedlar and his co-conspirators falsely promised financially distressed homeowners, including elderly individuals, that if they paid fees and transferred their homes to Grand View Financial, the company would eliminate the mortgage liens and return the properties to the homeowners. Instead, the defendants filed false court documents, false bankruptcy cases, and false documents with county recorders' offices that stalled the foreclosures but did not eliminate the liens, all while collecting fees from the victims. All of the victims lost their homes because of the scheme, resulting in a combined loss of more than \$7 million. The U.S. Trustee's Los Angeles office provided substantial assistance to the California State Attorney General, and to the joint federal and state agencies' investigation of the yearslong scheme. In addition, a Los Angeles based U.S. Trustee office Paralegal Specialist testified at the criminal trial about the bankruptcy process and the bankruptcy filings. Sedlar's co-conspirators entered guilty pleas before trial. Sentencing for Sedlar is set for July 21, 2023.

USA v. Zamir Siddiqi

On February 10, 2020, Zamir Siddiqi pleaded guilty to one count of making a false statement in a bankruptcy for failing to disclose his interest in an LLC. At the chapter 7 meeting of creditors, in response to the question, "Did you list all of your assets?" Siddiqi responded "Yes, sir." In fact, as Siddiqi then knew, at the time he filed his bankruptcy papers, he had additional substantial assets that were not listed, including an interest in Lagoon CCP, LLC. On March 9, 2023, the District Court entered a judgment and commitment order sentencing Siddiqi to 18 months imprisonment, followed by 2 years of supervised release, \$100 special assessment, and \$336,373.77 in restitution.
