

CHIEF JUDGE MAUREEN A. TIGHE SUCCEEDS SHERI BLUEBOND AT PASSING OF THE GAVEL CEREMONY

On January 31, the change of Bankruptcy Court Chief Judge from Judge Sheri Bluebond to Judge Maureen A. Tighe was commemorated at the Passing of the Gavel ceremony in Pasadena. The ceremony took place at the Richard H. Chambers United States Court of Appeals. Over 260 people were in attendance to celebrate the occasion.

U.S. Marshal Singer opened court and led the pledge of allegiance. Chief Judge Tighe invited the group to join in a singalong of "This Land is Your Land" by Woody Guthrie, led by her wife, Trish Nugent, and law clerk, Christian Torimino. Following Clerk of Court Kathleen J. Campbell's Call of the Calendar, Chief Judge Tighe welcomed the distinguished guests in attendance, including district court judges, magistrate judges, and bankruptcy judges. She remarked that keeping the Court open was an accomplishment in itself, following the recent government shutdown, drawing applause from the audience.



Circuit Judge Kim McLane Wardlaw began her remarks by mentioning her background as the chair of the committee for the Ninth Circuit that recommended Chief Judge Tighe as a bankruptcy judge. She discussed her own past work in the Central District as a district court judge and described the Passing of the Gavel ceremony as a celebration of the successful transition of leadership. She also provided a brief description of the Court of Appeals' merit-based judicial selection process.

Judge Scott C. Clarkson spoke about Judge Bluebond's tenure as chief judge—the text of his remarks follows this article—and Judge Sandra R. Klein spoke about Chief Judge Tighe's accomplished career in the Central District, which, she emphasized, is the largest and busiest district in the country. Judge Klein cited Jill Lepore's book These Truths on the importance of entrepreneurship in the history of the United States, which she tied to the bankruptcy system's role in fostering the American entrepreneurial spirit by abolishing debtors' prison. Judge Klein also charted Chief Judge Tighe's career as a federal prosecutor, in private practice, and at the Office of the U.S. Trustee. In addition, Judge Klein praised the "intellect, poise, and graciousness" evident throughout Chief Judge Tighe's career. In the U.S. Trustee's Office, as well as on the bench, Chief Judge Tighe has made a significant impact cracking down on fraudulent actors in the bankruptcy system, one of whom was imprisoned 71 months, Judge Klein said. Judge Klein recognized the impact of Chief Judge Tighe's clear message that abuse of the bankruptcy system in the Central District would not be tolerated. Judge Klein also described the way Judge Tighe's efforts led to broader changes across the nation, such as the creation of "the Tighe statute," or 18 U.S.C. §157. During her time with the Court, Chief Judge Tighe has worked to "demystify the court process" as chair of the Ninth Circuit Pro Se Committee, through her community outreach to students, and through the many national and local pro se groups with which Chief Judge Tighe has served, Judge Klein said.

Statistics Dashboard

<u>interactive</u> **Statistics** Dashboard is a new feature of the Court's website that provides upto-date filing and closing data for chapter 7, 11, and 13 cases, as well as adversary proceedings. Users can view data sorted by division or from the entire Central District, or they can choose to view only pro se or business cases. The Statistics Dashboard also displays year-by-year and month-by-month comparisons; another option compares each month of the current year to the corresponding month of the prior vear. Clerk of Court Kathleen J. Campbell congratulated Judge Bluebond on the completion of her term as chief judge, describing the recent consolidation of court space in Los Angeles as just one example of Judge Bluebond's successful leadership during her term as chief. Next, Ms. Campbell presented Judge Bluebond with a bronze statuette of Lady Justice, providing some background on the symbolic attributes of Justitia. She presented the statuette, engraved "With Gratitude for Your Leadership, Chief Judge Bluebond, 2015-2018," on behalf of the Clerk's Office, along with a gift certificate for use at the Hollywood Bowl or Disney Hall. As Judge Bluebond requested, judges who wished to give gifts donated instead to the Anti-Defamation League.

Judge Brand thanked the many bar organizations that sponsored the Passing of the Gavel reception: the Central District Consumer Bankruptcy Attorneys Association, the Century City Bar Association, the Los Angeles Chapter of the Federal Bar Association, the Financial Lawyers Conference, the Inland Empire Bankruptcy Forum, the International Women's Insolvency and Restructuring Confederation, the LGBT Bar Association of Los Angeles, the Los Angeles Bankruptcy Forum, the Los Angeles County Bar Association, the Orange County Bankruptcy Forum, the San Fernando Valley Bar Association, and the Southern California Chapter of the Turnaround Management Association.

Presenting Judge Bluebond with a portrait by Gary Miyatake, attorneys Whitman L. Holt of Klee Tuchin, Bogdanoff & Stern, LLP, and Robert S. Marticello of Smiley Wang-Ekvall, LLP, praised her intelligence, demeanor, and receptiveness to input from stakeholders. Mr. Holt described the special challenges of the role of Chief Bankruptcy Judge in the Central District, a massive "battleship" of a court with more than twice as many judges as any other bankruptcy court in the country. Mr. Marticello commended Judge Bluebond for her outreach to the bar: "As Chief Judge, Judge Bluebond was dedicated to strengthening the relationship between the bar and the bench and improving the Court. She empowered the lawyer representatives to voice concerns that were important to the bar, and voicing concerns to judges is not always an easy thing to do. And she worked with the lawyer representatives to develop solutions solutions to improve the Court for the attorneys, for our clients, and for the public. And while she didn't have to be, she was approachable. She made a concerted effort to reach out to the lawyers and put them at ease, all of which fostered the sharing of ideas between the bench and the bar." Judge Bluebond expressed her thanks for the portrait and for the kind words. She introduced Mr. Miyatake, whose grandfather is known for his photographic work at Manzanar Internment Camp, where the Miyatake family was interned during World War II. Judge Bluebond also expressed her thanks to Judge Brand for organizing the Passing of the Gavel and to Judge Clarkson for his remarks. Judge Bluebond thanked the judges of the Central District who would volunteer to assist whenever they were needed during her four-year term, Kathy Campbell and her staff, and gave a shout-out to her law clerks, closing with thanks to her husband, children, and parents. Judge Bluebond then described her time as chief as the "most satisfying accomplishment of her career."

Chief District Judge Virginia A. Phillips read the order of appointment designating Judge Tighe. Accepting the gavel from Judge Bluebond, Chief Judge Tighe commented on the tumultuous events of her term's first month and their effect on her plans. The Anti-Deficiency Act had become the unexpected focus of her thoughts at the year's beginning, she said, because of the record-breaking length of the government shutdown. Chief Judge Tighe expressed her confidence in the Court's judges and staff and noted their dedication in the face of the government shutdown. She thanked the Circuit and District Courts and pointed out the importance of family and friends when taking on any challenge, thanking her wife, daughter, mother, sister, niece, and nephew. At the reception in the lobby of the Court of Appeals following the ceremony, guests mingled over hors d'oeuvres and refreshments.

JUDGE SCOTT C. CLARKSON'S REMARKS AT PASSING OF THE GAVEL CEREMONY

Everybody defines leadership differently, but I prefer this explanation: "A leader is one who **knows** the way, **goes** the way, and **shows** the way." A great leader can prove to be the difference between success and failure, and it is axiomatic that a true leader has a futuristic vision and knows how to turn her ideas into real-world success. This, my bankruptcy community friends, is the legacy of Judge Sheri Bluebond and her now completed term as our Chief Judge.

In the few minutes I have today, I'd like to provide a very partial list of Judge Bluebond's traits and attributes that have **served** magnificently our entire Court and **provided** a remarkable four years of progress, growth and multiple successes.

These are my observations:

1. Judge Bluebond's Honesty and Integrity

The supreme quality of leadership is unquestionably integrity. Without it, no real success is possible. Judge Bluebond's universal reputation for honesty and integrity has provided her with the firm foundation underlying her leadership roles with our Court. Judge Bluebond, throughout her career, has demonstrated her commitment to principled values, core beliefs, and ethics, and these attributes have provided her with the basic building blocks of great leadership and service to our Court.

2. Her Confidence and Inspiration

I'll be honest. I've known Judge Bluebond for almost three decades, first serving with her on the Los Angeles County Bar Association's Bankruptcy Committee and its Commercial Law and Bankruptcy Section back in 1991. She was already a leader with those groups at the time, and my first observation was that she was "oozing" with confidence. While working hard with the bar committees to make the practice of bankruptcy and commercial law better for all of us, she, with a few brave others, undertook a decade-long critical demand for financial transparency by the parent organization. Through her and others' efforts, and at some personal risk, significant results were obtained.

Fast forward a decade or so, and we find that as Chief Judge over the past four years, her confidence continued unabated, **inspiring** all of us to consider alternatives, **exploring** creative options and directly **addressing** a multitude of important issues before us. Her contagiously positive thinking, her direct approach, and her wicked sense of humor have led the way in addressing both substantive and procedural matters. She truly believes that creative thinking and constant innovation is what makes our Bankruptcy Court for the Central District of California stand out from the rest of the county.

She has inspired us all to **take** the extra step, go the extra mile, and **look** for one more thing that we can do for the public good.

3. Her Commitment and Passion

Over the last four years of significant procedural rule changes in bankruptcy practice, accompanied by continuous internal Court budgetary and staffing level pressures, I witnessed first-hand Judge Bluebond's calmness under pressure and ability to motivate everyone to rise to various challenges facing the Court. Her secret, in my opinion, was the enormous commitment and passion for the Court itself, her fellow judges, and the legal community at large that she has always served. Her unrelenting motivation to make people's lives and jobs better is based almost entirely on her commitment and passion toward the Judiciary, law, and justice, and the people served by those institutions and principles.

Conclusion

I could go on for a much longer time in extolling Judge Bluebond's virtues and talents that have contributed so greatly to our Central District. Suffice to say that she has performed her duties with remarkable skill, dedication, and passion, and the results could not be clearer.

Judge Bluebond, we are assured and confident that you will never cease to provide us with your continued support, direction and wisdom in all matters "Central District." We thank you for your service as Chief Judge, as well as your personal friendship to all of us.

When filing Amended Motions with fees, please remember to use only the X-Amended Motion (Generic) (motion) event to avoid incurring duplicate charges/payments.

Avoiding Duplicate Charges/Payments - On-Line Credit Card Payments
When making payments in CM/ECF via Pay.gov, please remember:

- Do not use the browser button at any time during the payment process.
- Do not double-click the Submit payment button at any time.
- If you have submitted payment and you encounter computer problems, do not attempt to submit payment again.

Doing any of the above may result in a duplicate charge to the attorney's credit card.

To Verify Payments or View Payment History in CM/ECF

The following reports are useful tools for balancing your credit card statement. You may access these reports by selecting "Utilities" from the CM/ECF main menu.

- To run the payments due report, click on Utilities > Internet Payments Due.
 - o If a payment or payments are due, A Payment Summary screen will display. Select items to be paid and proceed with payment.
