PROPOSED CHAPTER 13 CHANGES; MAY 18 DEADLINE FOR COMMENTS

A revised form of chapter 13 plan, revised Local Bankruptcy Rule (LBR) 3015-1, and revised notices of § 341(a) meeting and confirmation hearing (§ 341(a) notices) have been tentatively approved by the bankruptcy judges for the Central District of California. These documents were prepared in coordination with a committee of local representatives from the debtor bar, the creditor bar, and the chapter 13 trustees.

These revisions are prompted by changes to the national rules, which are expected to become effective as of December 1. There are two forms of § 341(a) notices because the new national rules provide two different procedures regarding the treatment of secured claims: valuation and lien avoidance can be done via motion practice (as is currently done) or alternatively in some circumstances they can be done in the plan itself (and this requires special procedures for which a special § 341(a) notice has been drafted).

over 80 percent of its students. Over 400 students (about 350 from college, 50 from high school) signed up to attend this year's Federal Career Day, and the six local Rotary Clubs joined together to provide a BBQ lunch for all students and participants.

Bankruptcy Judge Maureen A. Tighe kicked off the program. She told the assembled students that the federal government values diversity of all sorts and that it is important to stay in school. Then, in an inspirational speech, Senior District Judge Consuelo Marshall offered practical advice to the students as she reflected on her career. The first woman ever hired at the Los Angeles City Attorney's office, she became the first woman of color to serve as Chief District Judge in any federal district west of the Mississippi.

Judges Tighe and Marshall then discussed preparing for careers in government with a panel of 14 federal agents, including representatives from Immigration and Customs Enforcement, the Bureau of Prisons, the Equal Employment Opportunity Commission, the Bankruptcy Court, Probation, NASA, the Federal Air Marshals, DEA, the Criminal Investigation Division of the IRS, the Postal Inspection Service, Pretrial Services, the United States Attorney's Office, the FBI, and the U.S. Marshals Service. The panelists described their duties, the career and education paths that led them to their positions, and their favorite aspects of their jobs. The panel also covered getting a security clearance, dealing with stress, developing skills for a career in government, and student internships.

Following the panel discussion, students had the opportunity to meet personnel from numerous other federal agencies in an adjacent building. Bankruptcy Judges Peter Carroll, Sandra Klein, and Martin Barash circulated among the guests along with Clerk of Court Kathleen J. Campbell, making sure students found the people or answers they were seeking. Judge Barash sent the students home on a high note, concluding the program with a rousing and encouraging speech.

LAW DAY CELEBRATION KICKS OFF CIVICS CONTEST WITH A LOOK BACK AT JAPANESE INTERNMENT

On March 28, the Court hosted a Law Day event for over 100 high school students at the Richard H. Chambers U.S. Court of Appeals in Pasadena. The event was held in conjunction with the Ninth Circuit Civics Contest, an essay and video contest for high school students, with the theme: "Not to be Forgotten: Legal Lessons of the Japanese Internment."



Among the numerous judges who participated in the event were Bankruptcy Judges Thomas B. Donovan, Robert N. Kwan, Sandra R. Klein, and Martin R. Barash; Senior Ninth Circuit Judges Raymond C. Fisher, Dorothy W. Nelson and A. Wallace Tashima; Senior District Court Judges Terry Hatter, Jr. and Ronald S.W. Lew; District Judges Lourdes G. Baird (Ret.) and John A. Kronstadt; Magistrate Judge Paul L. Abrams; and Los Angeles Superior Court Judges Firdaus F. Dordi, Jon R. Takasugi, and Melissa N. Widdifield. Sandra Brown, the acting United States Attorney for the Central District of California, also took part. There were several special guests, including Sandra Alarcón, widow of the late Hon. Arthur L. Alarcón; Eve Fisher, a Ninth Circuit Senior Deputy Clerk; David Madden, the Ninth Circuit Assistant Circuit Executive for Public Information; and Molly C. Dwyer, the Ninth Circuit Clerk of Court. Bankruptcy Clerk of Court and Executive Officer Kathy Campbell, as well as members of her staff, also attended and helped make the event a huge success. A number of attorneys volunteered during the event, including assistant United States attorneys, deputy federal public defenders, and attorneys from private practice.

The Law Day event began with brief opening remarks from Judge Klein. Judge Fisher welcomed the students on behalf of the Ninth Circuit Court of Appeals, Judge Kronstadt on behalf of the District Court. Judge Klein then introduced each judge. Following a brief summary of the events leading up to the Japanese internment and an overview of the Supreme Court decisions in Hirabayashi and Korematsu, Judge Klein introduced the panel of guest speakers: Judge Tashima, Judge Takasugi, Patricia Kinaga, and Gary Toyo Miyatake. The speakers shared poignant stories about their families' experiences during the Japanese internment.

The Law Day audience was fully engrossed in the discussion as the panelists recounted their experiences and those of their families during the internment. Judge Klein mentioned that approximately 40 years after the internment, Congress created the Commission of Wartime Relocation and Internment of Civilians, which studied how the interment could have happened. The Commission determined there were three reasons: racism; fear and wartime hysteria; and a failure of leadership.

Judge Klein noted that one of the reasons that we continue to discuss the internment is to make sure it is not forgotten and that we learn from our past mistakes. As Judge Tashima stated so eloquently in an article that he wrote, "We study history because those who forget the past are condemned to repeat it."

CM/ECF TIPS

Avoiding Duplicate Charges/ Payments – Online Credit Card Payments

When making payments in CM/ECF via Pay.gov, please remember the following:

- Do not use the browser button at any time during the payment process.
- Do not double-click the "Submit payment" button at any time.
- If you have submitted payment and you encounter computer problems, do not attempt to submit payment again.

Doing any of the above may result in a duplicate charge to the attorney's credit card.

If at any time you experience any problems with processing your payment or have questions concerning payment, please contact the ECF Help Desk at (213) 894-2365 between the hours of 9 a.m. and 4 p.m., Monday through Friday, excluding federal holidays.

To Verify Payments or View Payment History in CM/ECF

Payment reports are useful tools for balancing your credit card statement. View these reports by selecting "Utilities" from the CM/ECF main menu.

- To run the "payments due" report, click on Utilities > Internet Payments Due. If a payment or payments are due, A Payment Summary screen will display. Select items to be paid and proceed with payment.
- To check your payment history, click on Utilities > Internet Payment History. Enter the date range and click Run Report, and the report will display.

Flattening a PDF (For use with Adobe Professional version 10 or higher)

Note: To prevent serious document image quality issues, all files saved using Adobe Professional version 10 or higher must be "flattened" before filing through CM/ECF. Flattening a PDF file removes the interactive capability of the document created in Adobe Professional version 10 or higher and may also reduce the PDF file size by up to 90 percent.

- Create a PDF document for filing as usual.
- From the Print feature, select Adobe PDF as the printer.
- Click the "Print" button at the bottom of the screen. (You will be prompted to name your file and save it.)
- Upload the document into CM/ ECF using normal procedures.
