On the evenina of Thursday. October 25. Public Counsel hosted the 2018 William J. Lasarow Awards in the lobby of the Edward R. Roybal Federal Building and U.S. Courthouse in Los Angeles. The awards were held during the American Bar Association's National Pro Bono Celebration

<u>Week</u>. Approximately 60 guests were welcomed by Public Counsel Supervising Attorney Magdalena Reyes Bordeaux, who greeted the crowd with opening remarks.

Attorneys, court staff, and judges attended the awards ceremony, including Chief Judge Sheri Bluebond and Judges Vincent P. Zurzolo, Ernest M. Robles, Maureen A. Tighe, Robert N. Kwan, Deborah J. Saltzman, and Sandra R. Klein. Keynote speakers took turns commending the volunteers. In his humorous remarks, Judge Zurzolo guoted Ambrose Bierce on the challenges litigants face; Bierce described a litigant as "a person about to give up his skin for the hope of retaining his bones" and litigation as "a machine which you go into as a pig and come out of as a sausage." Chief Judge Bluebond thanked the volunteers for the outstanding service they provide and noted that although the Central District's percentage of pro se bankruptcy filings has fallen, it remains the highest in the nation at just over 17 percent.

Representatives of the pro bono organizations that staff the Court's self-help desks then presented awards to volunteer attorneys. The winners were M. Jonathan Hayes (Los Angeles Division/Public Counsel's Debtor Assistance Project), Ryan Zick (Northern Division/Legal Aid Foundation of Santa Barbara County), Anerio Altman

Margaret M. Morrow also presented a special award to the staff of the U.S. Bankruptcy Court. President Morrow credited the Central District as an early advocate for pro se causes and praised the Court for establishing self-help desks at each division. Executive Officer/Clerk of Court Kathleen J. Campbell accepted the award on behalf of the Clerk's Office, expressing thanks to Public Counsel and the pro volunteers who partner with the Court to increase the public's access to justice. She asked all members of the Clerk's Office to stand and be recognized, noting that the Clerk's staff represent the best in government. She then introduced three Los Angeles Division staff members, Jose Arias, Kim Collins and Olivia Ventura, noting that they represent Intake staff districtwide, working directly with Public Counsel and pro se litigants. Mr. Arias spoke about his appreciation for the partnership with Public Counsel's staff and explained that the Los Angeles Help Desk volunteers guide litigants so that are better informed when interacting with Court. He also noted that the recent relocation and physical presence of Public Counsel in the new Intake area promoted better service to the public, allowing Intake staff to quickly refer customers needing legal advice directly to attorney volunteers. Ms. Collins also expressed her thanks and appreciation to Public Counsel and noted the rewards that come with serving the public.

FOUR JUDGES ADDED TO LOAN MODIFICATION MANAGEMENT PILOT PROGRAM

Chief Judge Sheri Bluebond and Judges Vincent P. Zurzolo, Maureen Tighe, and Victoria S. Kaufman are now participating in the Court's Loan Modification Management Pilot Program (LMM), a forum for debtors and creditors to reach a consensual resolution when a debtor's property is at risk of foreclosure. <u>The LMM forms and procedures</u> are only available to parties whose cases have been assigned to one of the 12 judges currently participating in the program, whose names are listed on the Court's <u>LMM webpage</u>.

NEW LBR AMENDMENTS TO BECOME EFFECTIVE JANUARY 2, 2019

Amendments to the Court's Local Bankruptcy Rules will become effective on January 2, 2019. From the <u>redline posted on the Court's website</u>, the proposed amendments are:

- LBR 2091-1, "Attorneys Withdrawal, Substitution, and Change of Address," will be amended to clarify the process for withdrawal or substitution of attorney and to require a motion when an individual represented by an attorney desires to represent himself or herself.
- LBR 7026-1(b)(1), "Discovery Conference and Disclosures," will be amended to remedy existing ambiguities about when Rule 26 disclosures must be made.
- LBR 9011-2(b), "Persons Appearing Without Counsel," will be amended to clarify what it means for an individual to appear personally.
- LBR 9013-1(j), "Motion Practice and Contested Matters," will include a technical revision for consistency: "unrepresented" will be changed to "self-represented."
- LBR 9021-1(b)(3), "Orders and Judgments," will be amended to address an inconsistency between LBR 9021-1 and judges' practices related to the holding period for lodged orders.

The Court will not issue any new or revised LBR forms this December.

AMENDMENTS TO FEDERAL RULES OF BANKRUPTCY PROCEDURE EFFECTIVE DECEMBER 1

The proposed amendments to the Federal Rules of Bankruptcy Procedure approved by the Judicial Conference in September of 2017 will take effect on December 1 of this year, absent congressional intervention. The amendments package would affect FRBP 3002.1, 5005, 7004, 7062, 8002, 8006, 8007, 8010, 8011, 8013, 8015, 8016, 8017, 8021, 8022, and 9025. It also includes a new rule, 8018.1, and a new Part VIII Appendix.

FIFTEENTH ANNUAL BANKRUPTCY ETHICS SYMPOSIUM TO BE HELD AT ROYBAL BUILDING



CHINESE TAX OFFICIALS TOUR LOS ANGELES DIVISION

On November 2, a group of 25 members of China's National Tax Bureau visited the Los Angeles Division to learn about the American legal system and bankruptcy law. After Judge Robert N. Kwan welcomed them in his courtroom and provided an overview of the bankruptcy process, Clerk's Office staff led them on a tour of the Court. The group then returned to Judge Kwan's courtroom to meet Chief Judge Sheri Bluebond and discuss bankruptcy with Judge Kwan. Each member of the delegation received a token with the Court's official seal.

JUDGE SCOTT C. CLARKSON LECTURES ON REMBRANDT'S LIFE AND BANKRUPTCY

JUDGE SANDRA R. KLEIN SWEARS IN OVER 2,600 NEW CITIZENS

On September 18, during an early morning ceremony at the Los Angeles Convention Center, Judge Sandra R. Klein administered the Oath of Allegiance to the United States of America to 2,605 new citizens.

Addressing the crowd, Judge Klein described the journeys two of her grandparents made from Lithuania and England to the United States, and the flag her family still has from her grandmother's naturalization in 1939. She applauded the new U.S.



citizens for their hard work, commitment, and sacrifice, and reminded them that America is a melting pot of different ideas, cultures, and beliefs. As John F. Kennedy said, "Immigrants have enriched and strengthened the fabric of American life."

Judge Klein concluded her speech with a quote from John Quincy Adams: "You will never know how much it cost my generation to preserve your freedom. I hope you will make good use of it." She urged the new citizens to take good care of our country and to make good use of their freedoms as U.S. citizens. Among those naturalized at the ceremony were four U.S. military service members from American Samoa, Korea, and the Philippines, who were specially honored after Judge Klein's remarks.

Avoiding Duplicate Charges/ Payments - Online Credit Card Payments

When to File a Motion to Reopen a Bankruptcy Case

A Motion to Reopen a bankruptcy case should be filed only when the bankruptcy case has been closed. The case docket must be reviewed to verify that the case is closed prior to filing this Motion. If the Motion to Reopen event code is used to file the document and the case is still open, users will still be required to pay the appropriate filing fee.

Motion Filed on the Wrong Bankruptcy Matter

When a motion is filed in the wrong bankruptcy case, the Court's procedure is that the incorrect motion must be withdrawn by filing a pleading using the Voluntary Dismissal of Motion event code. If the incorrectly filed document is a fee motion, you must pay the fee upon filing it in the correct case, then make a written request for a refund on the incorrect filing by emailing the ECF Support Desk at ecf_support@cacb.uscourts.gov.

Verify Payments or View Payment History in CM/ECF

The following reports are useful tools in balancing your credit card statement. You may access these reports by selecting "Utilities" from the CM/ECF main menu.

- To run the payments due report, click on Utilities > Internet Payments Due. If a payment or payments are due, A Payment Summary screen will display. Select items to be paid and proceed with payment.
- To check your payment history, click on Utilities > Internet Payment History. Enter the date range. Click Run Report. The report will display.
