## SELECT INTAKE AREAS REOPEN AMID CORONAVIRUS (COVID-19) PANDEMIC

On September 28, the Intake area of the San Fernando Valley Division Courthouse reopened to the public to accept in-person filings per General Order 20-07. Additionally, the Intake areas of the Ronald Reagan Federal Building and U.S. Courthouse in Santa Ana reopened to the public on September 14 per Amended General Order 20-06 and the Northern Division Courthouse in Santa Barbara reopened to the public on October 19 per General Order 20-09. The Intake area of the Edward R. Roybal Federal Building in Los Angeles will remain open to the public and will be able to accept in-person emergency filings from any division. The Intake area in the Riverside Division remains closed. Please check the Court's Coronavirus (COVID-19) and Court Operations website for updated information.

#### LIMITED EMERGENCY IN-PERSON HEARINGS

In-person access to the Court will generally not be permitted except for the filing Intake areas of the Los Effective October 14, the Court is releasing a new Angeles, Santa and San Fernando Valley Ana, courthouses. Bankruptcy judges will continue to hear matters remotely through telephonic or video services, except a judge may order an in-person hearing where necessary in an emergency.

Court's Continuity Operations Plan The of ("COOP") implemented on March 18, 2020, will remain in place and be modified gradually as necessary. Details of these modifications will be posted on the Court's website as they are implemented.

#### **TEMPERATURE SCANNERS IN SAN FERNANDO VALLEY AND SANTA BARBARA**

Non-contact temperature scanners have been installed at the San Fernando Valley Division Courthouse and Northern (Santa Barbara) Division Courthouse. All visitors to the two locations will be required to have their forehead or wrist scanned before entering.

All visitors with a temperature below the Center for Disease Control and Prevention guideline of 100.4 degrees will be allowed entry. In instances when a visitor has been detected to have a high body temperature, the scanners will sound an audible alarm to notify the Court Security Officers to prohibit entry into the building. Signage is available to all visitors on the proper use of the scanner. The scanners have been programmed only to capture the number of visitors admitted entrance into the courthouse and do not store actual temperature data.

An elevated temperature is one way to identify a person who may have a COVID-19 infection, although an infected person may be contagious without an elevated temperature or other easily detectable symptoms.



#### HONOR ROLL RECOGNITION DURING NATIONAL PRO BONO CELEBRATION WEEK

The 12th annual National Celebration of Pro Bono week takes place October 25-31. Created by the American Bar Association, this year's theme is "Rising to Meet the Challenge: Pro Bono Response to COVID-19." The celebration recognizes the volunteers who help those who do not have an attorney, providing pro bono assistance, and promotes training for pro bono volunteers. Nationwide, the number of participating events has more than tripled since the ABA's Celebration Week began. The Court celebrates National Celebration of Pro Bono Week with the publication of the Honor Roll to its website, listing the names of bankruptcy pro bono volunteers assisting the Central District.

The Honor Roll is published under "Programs and Services for Attorneys," and is based on the names submitted by each of the Court's self-help desks (for the 12 months ending in October) to recognize volunteers for each organization. In previous years, and with funding provided by District Court's Attorney Admission Fund (AAF), the Court has hosted its own Honor Roll receptions or recognized volunteers by partnering with local bar association events. Due to the spread of Coronavirus and following Riverside's recognition event at the Inland Empire Bankruptcy Forum (IEBF)'s "Ask the Judges Night," this year's Honor Roll receptions for volunteers at the remaining divisions were canceled or were not scheduled. Despite being unable to gather in person, the Court is providing recognition to pro bono volunteers in the form of "swag bags," made possible by the AAF.

For volunteers named on the Honor Roll who served at Help Desks in the Northern, San Fernando Valley, Santa Ana and Los Angeles divisions, swag bags will be available for pick up at the division hosting the Help Desk where each volunteer has served. Pick up availability will be subject to change, depending upon whether the division has reopened to the public. #### JUDGE ROBERT N. KWAN TO RETIRE



# **BANKRUPTCY FRAUD PROSECUTIONS**

The following information has been provided by the Office of the United States Trustee:

#### USA vs. Daniel Kamensky

Daniel Kamensky, the founder and manager of New York-based hedge fund Marble Ridge Capital
has been charged in a Complaint in Manhattan federal court with one count of fraud in the offer or
sale of securities, which carries a maximum sentence of five years in prison, one count of wire
fraud, which carries a maximum sentence of 20 years in prison, one count of extortion and bribery
in connection with a bankruptcy, which carries a maximum sentence of five years in prison, and
one count of obstruction of justice, which carries a maximum sentence of 20 years in prison. The
allegations are in connection with an alleged scheme to pressure a rival bidder to abandon its
higher bid for assets in connection with the Neiman Marcus bankruptcy proceeding, in violation of
his fiduciary duty as a member of the Official Committee of Unsecured Creditors in the Neiman

USA vs. Robert Kowalski

Robert Kowalski, a Chapter 7 debtor in Chicago, IL, has been indicted for allegedly defrauding the creditors, primarily the Federal Deposit Insurance Corporation, and trustee in his bankruptcy case by concealing cash and property belonging to the estate. It is alleged that bank employees conspired with Kowalski and higher-ranking bank officials to embezzle at least \$29 million in bank funds in the years preceding the shutdown of Washington Federal Bank for Savings. The Bank was determined insolvent by the Office of the Comptroller of the Currency in December 2017 and had a least \$66 million in nonperforming loans. Kowalski has been charged with bankruptcy fraud charges, conspiracy to commit embezzlement, falsify bank records and failure to file income tax returns and filing false personal and corporate returns for various years.
