# JUDGE MAGDALENA REYES BORDEAUX PROFILED IN RIVERSIDE LAWYER MAGAZINE

The July/August issue of the Riverside Lawyer Magazine features a profile of Judge Magdalena Reyes Bordeaux. The profile, authored by Michael Gouveia, covers Judge Reyes Bordeaux's early years, lessons learned at Public Counsel, and her continuing commitment to access to justice.

The profile briefly follows Judge Reyes Bordeaux's path to judgeship, including the vital role her mother played in her journey. "The most important things I learned from her was to treat people with respect, to always do the right (even when it's hard), and to never give up. If something did not go her way, she always seemed to find another way to make things work." In working at Public Counsel, Judge Reyes Bordeaux emphasized the importance of being courteous, patient, and empathetic. "I still remember how much it meant to my former clients that I took the time to actively listen. Many of them just wanted an opportunity to tell their story and to be heard—and I will never forget that."

Judge Reyes Bordeaux noted the mentorship of Judge Tighe and Judge Zurzolo early in her legal career. When asked about the goals in taking the bankruptcy bench,



Judge Reyes Bordeaux stated, "To serve. I look forward to working hard every day to ensure that everyone appearing before my court is treated fairly, compassionately, and most importantly feels heard and understands my rulings."

## **JUDGE ERITHE A. SMITH RETIRES, CASES REASSIGNED**

On October 29, Judge Erithe A. Smith will retire from the bench after serving over twenty-eight years as a bankruptcy judge. The recipient of the Judge of the Year by the Orange County Women Lawyers Association and John M. Langston Bar Association's Hall of Fame inductee was appointed to her first 14-year term as a bankruptcy judge on May 2, 1994 and reappointed to a second term on May 2, 2008. Judge Smith has been approved to serve as a recalled judge for the Central District of California. On September 1, most of Judge Smith's pending bankruptcy cases and related bankruptcy proceedings were reassigned to the other judges at the Santa Ana Division, as specified in the table at the following link.



# GENERAL ORDER 22-01 IN RE: PROHIBITION ON BROADCASTING, TELEVISING, RECORDING, AND PHOTOGRAPHING BANKRUPTCY COURT PROCEEDINGS, INCLUDING HEARINGS CONDUCTED BY REMOTE TRANSMISSION

On September 8, 2022, Chief Judge Theodor C. Albert issued <u>General Order 22-01 In Re: Prohibition on Broadcasting, Televising, Recording, and Photographing Bankruptcy Court Proceedings, including Hearings Conducted by Remote Transmission. General Order 22-01 was ordered to effectuate the policy of the Judicial Conference which prohibits federal court proceedings from being broadcast, televised, recorded or photographed for the purpose of public dissemination. General Order 22-01 reconciles the use of videoconferencing and telephone conferencing during the COVID-19 pandemic with the Judicial Conference's policy, as remote transmission was not expressly addressed in the applicable Local Bankruptcy Rule (LBR 5073-1).</u>



### BANKRUPTCY FRAUD PROSECUTIONS

The following information has been provided by the Office of the United States Trustee:

#### USA v. Smith

On July 28, 2022 Jonathan Smith Lee, who managed and owned two Hollywood-based reality TV production companies, was sentenced to 12 months and one day in federal prison for fraudulently obtaining a \$2 million business loan using fabricated documents and mispresenting his companies' financial circumstances. Smith falsely represented that his companies had accounts receivable of \$3,348,000. He submitted falsified license agreements, other forgeries documents and then created a false record showing a \$100,000 wire payment in an attempt to convince the lender that a payment had been made when, in fact, it had not. Lee then placed both companies into Chapter 11 bankruptcy protection in a further attempt to delay, hinder and defraud his creditors. Press Release

#### USA v Avenatti

On June 16, 2022 suspended attorney Michael Avenatti plead guilty to four counts of wire fraud and one count of endeavoring to obstruct the administration of the Internal Revenue Service. Avenatti still faces a total of 31 counts including wire fraud, tax related charges, bank fraud, aggravated identity theft and four counts of bankruptcy fraud. <a href="Press Release">Press Release</a>

#### People of the State of California v. Kim

On March 11, 2022 Chong Yol Kim was convicted after trial on one count of foreclosure fraud, one count of filing false documents, one count of identity theft and one count of forgery. He was sentenced to 36 months in state prison, a \$5,000 fine and 80 hours of community service. Kim used the bankruptcy system to delay mortgage foreclosure and hinder and defraud financial institutions. The scheme involved 25 individual properties and the filing of chapter 7 and 13 bankruptcy petitions in the names of "ghost debtors".
