CENTRAL DISTRICT OF CALIFORNIA BANKRUPTCY COURT'S WORKSHOP FOR JUNIOR ATTORNEYS

The Court's mission statement is "to serve the most populous and diverse judicial district in the country by providing bankruptcy relief, fair and impartial justice, and a prompt and efficient resolution of disputes." One way the Court advances this mission is to sponsor, contribute to, and promote programs that are aimed at educating the bar and the public on matters of bankruptcy law and practice.

To this end, on October 26, 2023, from 3:00 p.m. to 4:30 p.m., the Court will offer an in-person workshop intended to foster the courtroom presentation skills of junior attorneys. The workshop will be held at the Roybal Federal Building, 255 E. Temple Street, Los Angeles, California 90012.



The workshop will provide each participant the opportunity to argue a simulated motion before one or more judges of the Court and receive constructive feedback in real time. This is not a competition. The workshop is being offered to provide a safe space for junior attorneys to gain experience in a courtroom setting. The workshop is open to attorneys with less than seven years of full-time equivalent work experience. Participants need not be currently practicing bankruptcy law.

Space for this program is limited. Please register as soon as possible, but only register if you know you are able to attend. Registration will be on a first come, first served basis. JUDICIAL CONFERENCE REVISES POLICY TO EXPAND REMOTE AUDIO ACCESS OVER ITS PRE-COVID POLICY

The Judicial Conference of the United States Courts has revised the policies with respect to video and audio broadcasting of courtroom matters for all civil and bankruptcy proceedings (District Courts and Bankruptcy Courts). The new policy will go into effect on Sept. 22, 2023, immediately after the expiration of the

temporary exception that was put into place by the Judiciary when access to courthouses was restricted for health and safety reasons. The exception allowed judges to permit remote audio access to any civil or bankruptcy proceeding. The revised policy, adopted at the Conference’s biennial meeting, will permit judges presiding over civil and bankruptcy cases to provide the public live audio access to non-trial proceedings that do not involve witness testimony. GENERAL ORDER 23-02 IN RE: COMPLEX CHAPTER 11 CASE DEFINITION AND PRE-FILING PROCEDURE

On July 31, 2023, Chief Judge Theodor C. Albert issued [General Order 23-02](#) which defines a complex chapter 11 case and outlines procedures to be followed prior to filing a complex chapter 11 case. General Order 23-02 was entered for the efficient administration of complex chapter 11 cases and followed a proposed revision to the Court’s procedures and subsequent comment period. 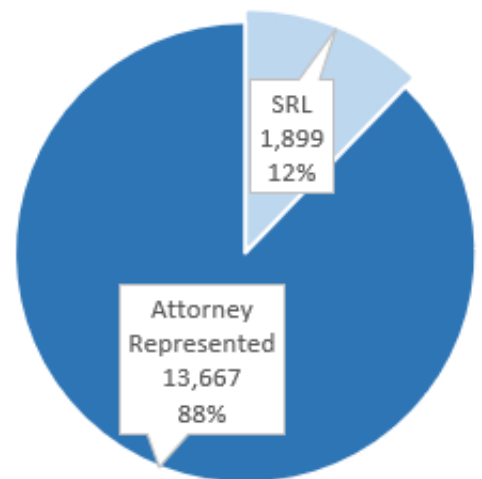

BANKRUPTCY FRAUD PROSECUTIONS

The following information has been provided by the Office of the United States Trustee:

In Re: Leroy Bishop Austin

The Supreme Court of the State of California issued an order effective March 17, 2023, disbaring Leroy Austin. Austin had been practicing bankruptcy law since 1995. In June of 2021, The State Bar of California suspended his license. Nevertheless, he continued to file bankruptcy petitions in violation of the suspension. The U.S. Trustee’s Santa Ana Office identified the violation and brought a motion before the bankruptcy court seeking disciplinary action which resulted in a two-year suspension from practicing before the bankruptcy courts in the Central District of California. Thereafter, the State Bar of California initiated further action seeking permanently to disbar Austin. At the State Bar trial, attorneys from the U.S. Trustee Program’s Santa Ana, San Jose and Oakland offices testified about the unauthorized practice of law by Austin. The State Bar judge then issued a decision recommending disbarment to the Supreme Court of California which adopted the recommendation and issued an order of disbarment.
